The 2019 African American Conference on Disabilities is a unique comprehensive all-day conference and is the only one of its kind in the United States that addresses the intersection between race and disabilities. The conference examines avenues for self-advocacy to ensure the effective provision of services, resources and enforcement of civil rights in the African American and Disability communities.

The vision of the conference is to form a society where individuals with disabilities enjoy full acceptance without barriers.

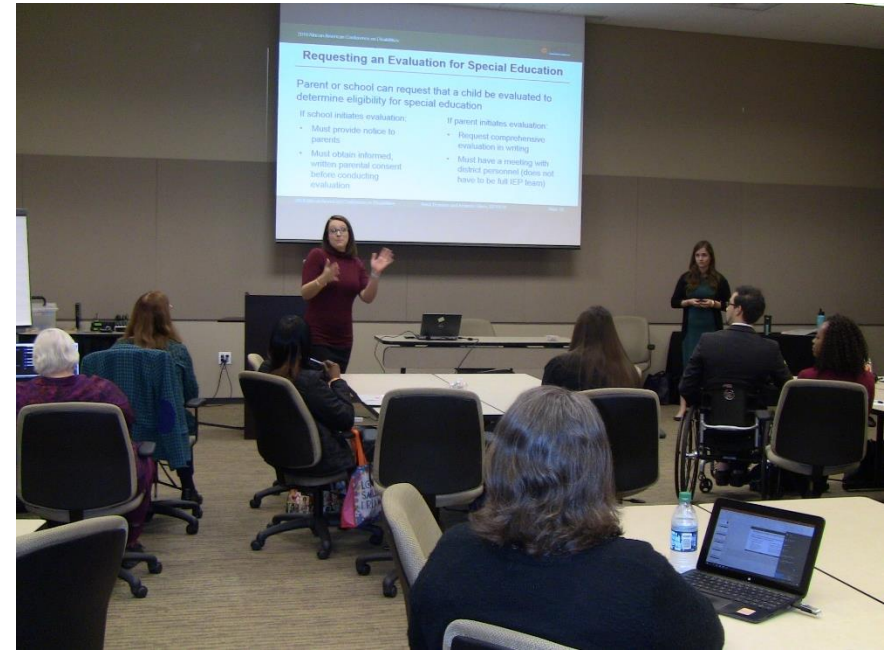

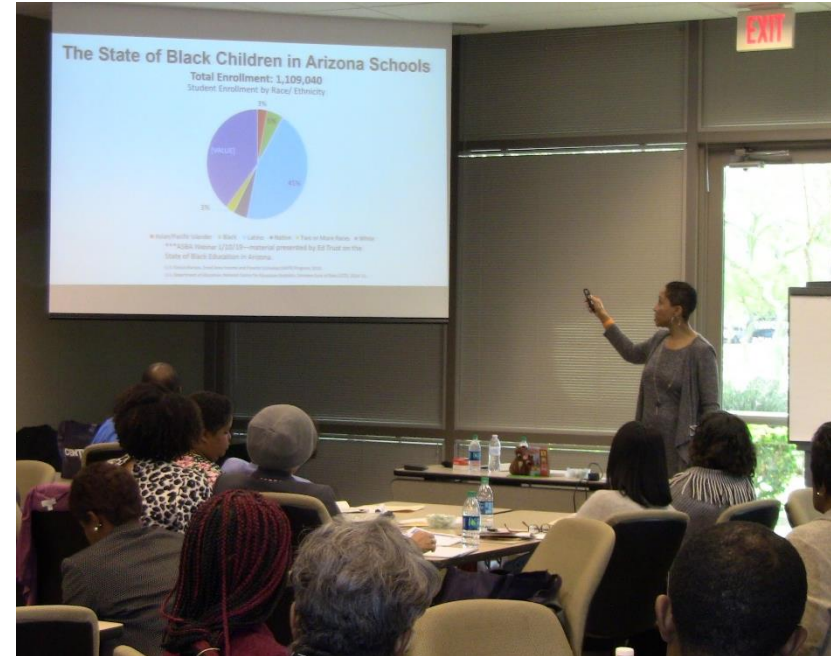

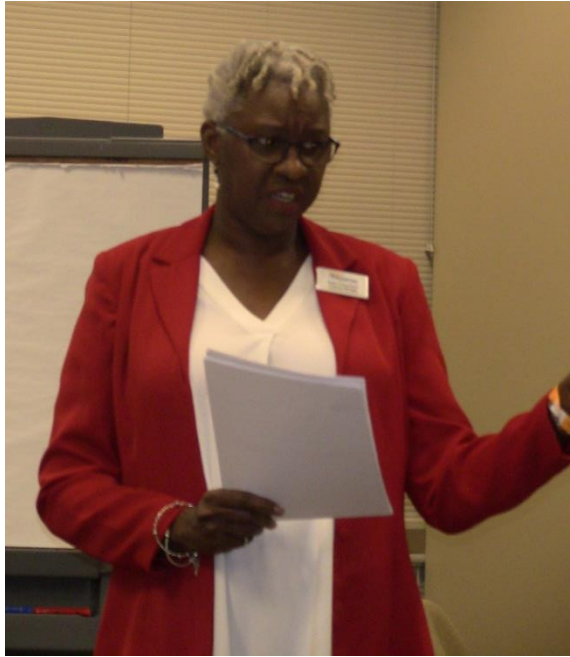
