- Payment to the Artist will be processed within 30 days after receipt of payment from the Buyer to the Gallery.

- The Artist accepts and agrees to follow the Artist Entry Package guidelines.
- Ineligible Artwork may be excluded at the discretion of Warman Arts Centre board members.
