1. Call to Order / Pledge of Allegiance

Trustee Beverage called the meeting to order at 7:00 P.M. followed by the Pledge of Allegiance.

2. Open Forum / Comments from the Public

3. Review, Correct and Approve Previous Meeting Minutes
