-Trustee Gifford brought up separating EMS funds and tax funds to have more freedom with the EMS funds as far as investing goes. Tax funds have stricter rules with investing. Will discuss again

on how to logistically do it.

-Water Softener - \$3692.00 to repair the current softener. Barrett's labor is only \$375 of that quote and includes %253.63 of sales tax which would end being removed for tax exemption. A new unit is \$3910. Trustee Weismiller motioned to get the new softener with Barrett's for \$3910 without any sales tax. Trustee Gifford seconded the motion. Trustees Weismiller, Gifford and Beverage all voted ves.

-Pheonix alerting system — Discussions on if the system will be lasting and around in a few years. Discussions about the towns west and south that have smaller budgets, how would they afford it?

Being tabled for a future discussion and to research more.

-2025 Auditor decision — No luck with quotes as ones that were reached out to do not audit Fire Departments. Will reach out to Newkirk & Associates as they audit for Somonauk FD. Trustee Gifford made a motion that he will reach out and get a quote from Newkirk & Assoc., Trustee Weismiller seconded the motion. Trustees Gifford, Weismiller and Beverage all voted yes.
-HVAC Maintenance Contract — There was a \$3400 per year maintenance contract presented for the HVAC system. It was decided to not to go with it as it would cost the department unneeded funds as most regular maintenance is performed in house. Call to get issues resolved as needed.
