As a dedicated breeder of Golden Retrievers, our responsibility is to do what is best for the breed and our puppies. Therefore, we have developed our contract to protect the purchaser, breeder and most importantly, the puppy. Under the terms of this contract, the undersigned parties agree to the following conditions:

My Golden Guardians, owner of the said puppy (described below) hereafter referred to as "Seller" do enter into an agreement with, _____ hereafter referred to as "Buyer", for the purpose of transferring ownership of the said puppy.

The said dog is a purebred registered Golden Retriever,

Registration papers will be transferred at the time of sale. The seller will transfer ownership of the said puppy for \$ _____, with limited registration as defined by the American Kennel Club. The puppy shall be paid in full by 8 weeks of age or at the time of pick up, whichever comes first.

Breeder hereby accepts a non-refundable holding fee of \$ _____, which was paid on _____ and shall be applied towards the purchase price of the puppy.

In the event the puppy is to be shipped, Buyer shall be responsible for all associated costs including transportation to the airport, shipping crate, airfare, vet certificate, etc.

Sales Agreements:

- Both the Sire and Dam are purebred and AKC registered. Both parents have health testing for hips and elbows as well as DNA testing PRCD, PRA1, PRA2, ICT, NCL.
- The dog is in good health at the time of purchase. The dog has also been loved daily and properly cared for to date and has been checked by a veterinarian. The puppy has received its first shots, wormed, and been micro-chipped. Immunization and de-worming records will be furnished at the time of delivery.
- Our dogs are primarily intended for families who desire a pet, therapy, obedience, and/or working dog. Dogs are not guaranteed to perform any specified tasks or desired function.
- That as of the signature date of this contract, both Sire and Dam have NOT been affected by cancer, epilepsy or allergic conditions to normal environmental stimuli.
- The Seller does not assume any liability for any injury or veterinarian expenses to purchased dog once picked up by the buyer or delivered safely by Seller to the airport/ground transportation personnel.

Buyer Agreements:

- Buyer agrees to have the dog examined by a licensed Veterinarian by their regular vet check to receive their next set of vaccines and to verify the dog is of sound health. If the veterinarian finds the dog to be at risk due to congenital defect (existing at birth), Buyer shall notify Seller and provide a written statement from licensed Veterinarian describing the puppy's condition and shall return, at Buyer's expense, the dog and registration papers to the Seller within three days of the examination. This return does not include worms, fleas, mites, ticks, coccidia, giardia, mange or any other parasites as they are common in dogs and puppies. It also does not include indigestion of foreign objects, ingestion of food or chemicals, or physical injury contracted or incurred following Buyer's receipt of the dog.
- In the event of the dogs death, the Buyer must notify the Seller within 24 hours.
- The dog is to receive proper veterinary care, vaccinations and nutrition for the duration of its life, along with proper training.
- The Buyer agrees NEVER to sell/give/trade/transfer ownership of this dog to any large commercial breeding establishment, any agent, any wholesaler, or any party not included in the original sales agreement. If more than one party purchases this puppy together both parties agree that dog may never be sold/given away/transfer of ownership to anyone not named in this contract. In the event of a dissolution between buyers on this contract and an agreement cannot be reached between the buyers, puppy shall be returned to the Seller at no cost to the Seller.
- In the event, at any future time, the Buyer cannot keep this dog, the Buyer must first notify the Seller. The Seller will assist with the rehoming of the puppy/dog if needed.

- Should the dog purchased under this agreement be returned for any reasons whatsoever, buyer accepts responsibility for, and shall pay, without recourse against the Seller, any and all transportation expenses, veterinary charges, crate fees, air freight charges, and transport fees to and from the involved destination.
- All transactions are NON-REFUNDABLE. All family members must be in agreement in regards to getting a pet. We do not refund deposits or purchase price due to family members with allergies, or your lease and/or homeowner associations not allowing pets or for any other reason. This is something that should be considered before buying the dog.
- Buyer(s) agrees to release and hold harmless My Golden Guardians for any and all liability, damages, or injuries, caused either directly or indirectly by this dog to any person, whether actual or legal, or to any property, whether real or personal. Furthermore, Buyer(s) assumes full liability for any damages or injuries, whether actual or legal, or to any property, whether real or personal, after receiving possession of this dog. Buyer(s) further agrees to indemnify or reimburse the Seller, as a result of any costs or expenses incurred as a result of any act of the Buyer(s) causing liability, damages, or injuries as set forth herein.

Health Guarantee:

My Golden Guardians guarantees this dog is free of major diseases (Parvo, Distemper, Corona, Rabies) for a period of 24 hours from the date of sale stated on the pet records.

My Golden Guardians also guarantees this dog to be free of genetic defects that can be tested for in the Golden Retriever Genetic panel with Paw Print Genetics until the puppy is 2 years of age. If the dog is found to have any congenital disorders (born with it) that can be proven to be genetic by a letter from a licensed Veterinarian, the Seller will replace the dog with another dog of the same sex from the first compatible litter. No money will be refunded. Buyer is responsible for all transportation expenses, veterinary charges, crate fees, air freight charges, and transport fees to and from the involved destination for the replacement puppy.

My Golden Guardians shall not be responsible for the death or injury of the dog due to negligence or carelessness of the buyer. Seller makes no guarantees regarding the loss of the dog due to an accidental death, sickness due to lack of vaccination, ect., or any other loss beyond the Seller's control, except as stated above. Seller is not responsible if dog contracts a communicable disease, parasites (internal or external) after leaving Sellers's possession.

This contract DOES NOT cover any environmental factors. Such as but not limited to allowing puppy/dog jumping in/out/on/off anything. Being placed in his/her crate for too long or if crate is too small. Slippery/Hard surfaces. Over exercising. Over fed or Under fed. Ect.

My golden Guardians does not guarantee future temperament, habits, and appearance of the dog.

Limitations of Guarantee:

If your dog displays any indication of poor health within the first 24 hours, we must be contacted and the dog must be brought back or taken to a licensed veterinarian for any necessary treatment, and signed documentation must come to us immediately. Failure to do so will cause this guarantee to become null and void.

The buyer agrees to be responsible pet owner & spay/neuter at an appropriate age as recommended by their veterinarian. This dog is sold with limited registration, so if this dog is bred then the guarantee will become null and void.
