#### INTRODUCTION

This course provides participants with the competencies required to perform effective internal audits for FSC certification systems including Chain of Custody (CoC), Controlled Wood, and related FSC requirements. Participants will learn audit principles, planning, execution, evidence gathering, reporting of findings, and follow-up of corrective actions in accordance with ISO 19011 audit guidelines and FSC certification rules. This training prepares internal auditors to evaluate compliance, identify gaps, improve documentation control, and ensure the organization maintains continual readiness for external FSC audits.

- Learn internal audit principles based on ISO 19011
- Develop an audit plan, checklist and sampling methods
- Understand FSC CoC and Controlled Wood requirements to audit against

- Improve organizational compliance and readiness for FSC certification audits
