INTRODUCTION

This training provides participants with the knowledge and guidance required to integrate the ISO 37001:2016 Climate Change Amendment into an organisation's Anti-Bribery Management System (ABMS). The amendment introduces new expectations for considering climate change impacts when planning and operating an ABMS. Participants will learn how climate-related disruptions can influence bribery risks, due diligence processes, supply chain vulnerabilities, governance mechanisms and organisational controls. The course explains documentation updates, risk assessment changes and auditor expectations for certification readiness.

OBJECTIVE(S):

- Understand the requirements and intent of the ISO 37001 Climate Change Amendment.
- Identify climate-related factors that may influence bribery risks and ABMS operations.
- Update the organisational context, issues and interested parties to include climate impacts.
- Integrate climate considerations into bribery risk assessment and due diligence processes.
- Identify climate-driven vulnerabilities in supply chain and business operations.
- Strengthen anti-bribery controls, reporting mechanisms and governance structures.
- Update ABMS documentation to reflect climate change considerations.
- Prepare necessary evidence for certification and surveillance audits.
