#### INTRODUCTION

This training provides participants with a comprehensive and practical understanding of ISO/IEC 27017 (cloud security controls) and ISO/IEC 27018 (PII protection in public cloud environments), focusing on how these standards strengthen an organisation's Information Security Management System (ISMS) and support safe, compliant and secure cloud adoption. The course explains cloud-specific security threats, privacy challenges and shared responsibility models while guiding participants through the additional controls required to protect information assets and personally identifiable information when using cloud-based services. Through case studies, workshops and cloud scenario exercises, participants will gain the capability to apply cloud security and privacy controls effectively and enhance organisational readiness for audits, certifications and regulatory obligations.
