Participants will learn CoC system requirements, material categories, volume control, due diligence systems and audit preparation. The course equips organisations with the capability to establish, implement and maintain an FSC CoC system that complies with certification standards and customer expectations.

- Understand FSC principles, system structure and certification requirements.
- Learn how FSC Chain of Custody ensures material traceability.
- Identify FSC material categories and labelling rules.
- Implement CoC procedures, documentation and volume control systems.
- Understand the FSC Due Diligence System (DDS) for risk management.
- Prepare for FSC certification audits and surveillance requirements.
- Strengthen organisational transparency and responsible sourcing practices.
- Ensure continuous compliance with FSC policies and customer requirements.
