READ BEFORE SIGNING**

IN CONSIDERATION of being permitted to participate in any Paintball and/or Airsoft activities including, but not limited to, playing, using the premises or renting and operating equipment leased, sanctioned and/or operated by **Ohioypyle Paintball Inc. (OPI)**, I acknowledge and agree that:

I fully understand and acknowledge that:(a) risk and dangers exist in my use of Paintball and/or Airsoft equipment and my participation in Paintball and/or Airsoft activities, (b) my participation in such activities and/or use of such equipment may result in my injury or illness including but not limited yo bodily injury, disease strains, fractures, partial and/or total paralysis, eye injury, blindness, heat stroke, heart attack, death or other ailments that could cause serious disability; (c) these risks and dangers may be caused by the negligence of the owners, employees, officers or agents of OPI; the negligence of the participants, the negligence of others, accidents, breaches of contract, the forces of nature or other causes. These risks and dangers may arise from foreseeable or unforeseeable causes; and (d) by my participation in these activities and/or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers, employees of OPI, or by any other person.
