Subject: Consulting Forester

As a result of our current consulting forester, Woodland Management Services (WMS) phasing out his company, the Authority requested proposals for a replacement forester and received four written proposals From the following firms:

Highland Forest Management
Ridge and Valley Forest Management
Forecon
Schultz Forest Management.

A summary of the proposals is attached to this memorandum.

Following our review of the proposals it was decided to conduct interviews with the first three listed firms above. The interviews were conducted on July 21 at our Wild Creek Office.

Following the interviews and further review of the proposals, we believe that any of the three interviewed firms could do the job for the Authority. We met on August 10 to integrate our respective thoughts of each firm and which one would best serve the Authority's interests. It was agreed that we would recommend to the full Board the appointment

of Highland Forest Management (HFM) as our Forestry Consultant and at the same time retain the services of WMS in an advisory role to assist HFM during a transition period, especially for the carbon aspects of the Authority's forest management activity.

HFM is owned by Mr. Rankin Smith and is a one person consulting firm. He offers the lowest rates of the proposers which would allow us to retain WMS for some as yet undefined time period. Mr. Smith has worked with and for WMS on several projects on Authority property over the last year and is a very hard worker and knowledgeable forester as described by Robin Wildermuth and also witnessed by myself and Eric Yeakel. We believe that with some additional mentoring by Robin, Mr. Smith will provide the Authority with the necessary tools and knowledge to serve us well into the future.
