## Writ of Habeas Corpus Ad Subjiciendum

### ORDER

Upon the Affidavit of Evidence and Information being attached hereto and having been sworn to by the affirmation of the Plaintiff, El Noble William Thomas - al Hasaan Bey, and witness, Maur Len Bey, based upon the facts asserted therein and brought before this Morocco Consular Court for the Texas and Oklahoma state republics,

It is on this 10th day of Dhul-Hijjah, in the year 1446 (06/06/2025 Gregorian), hereby ORDERED and Demanded Without Delay:

1.

You must without delay cease and desist the denationalization of our national, ibn Hasaan Thomas-Bey, correct the name and citizenship on records pertaining to case number **DR:24-CR-00879-AM** and **REG/A#: 12890511**, in the records of the foreign named UNITED STATES DISTRICT COURT WESTERN DISTRICT OF TEXAS DEL RIO DIVISION (Inc.), are to be corrected to ibn Hasaan Thomas-Bey (Race:

Human/asiatic) (Citizenship: Moorish-American). He is not a subject to the jurisdiction of the United States and is subject to the Moroccan Empire and you shall no longer make prize of him or his effects as of receipt of this order, per the Treaty of Peace and Friendship (1836).

2.

In accordance with the United States Department of State Consular Notification and Access Manual, you are obligated to provide our Moorish-American national, ibn Hasaan Thomas-Bey, case number **DR:24-CR-00879-AM** and **REG/A#: 12890511**, notification and access to his consulate without delay.

3.

In accordance with the authority under Articles 20, 21 and 24 of the Treaty of Peace and Friendship of 1836, between the United States of North America and the Moroccan Empire, and the "Supremacy Clause" of the Constitution for the United States of North America under Article VI, clause 2, you are to immediately schedule within (3) days a Habeas Corpus hearing for ibn Hasaan Thomas-Bey. You must also provide the Morocco Consular Court the date, time, and video-audio access to the hearing.

4.

You are hereby **COMMANDED** to produce the body of our Moorish-American National, ibn Hasaan Thomas-Bey, being detained on the information of a corporate fictional person styled: **HASAAN MARTEL THOMAS**, DOB: 08/10/1995, race: **BLACK**, **DR:24-CR-00879-AM** and **REG/A#12890511**, fictitious person, fictitious United State Citizen/USC, by way of the 14th Amendment unconstitutional "corporate person-Clause 1") at the foreign defacto prisoner-of-war camp know as **EDEN DETENTION CENTER (INC.)**, by **Phillip Valdez, UNITED STATES (Inc.) citizen**, (acting as) Warden, on 702 E Broadway St, Eden, TX 76837, to be **RELEASED** forthwith, without condition or delay, in accordance with Article 6, 20, 21 and 24 of the Treaty of Peace and Friendship of 1836, between the United States of North America and our country the Moroccan Empire.

5.

It is further **ORDERED** that the Sheriff for **CONCHO COUNTY, TEXAS**, shall give aid or assistance to our consulate general for the enforcement of this writ under consular jurisdiction pursuant to the treaty obligations set forth under Articles 4, 6, 20, 21 and 24 of the Treaty of Peace and Friendship of 1836 between the United States of North America and the Moroccan Empire;


It is further **ORDERED** that there shall be no cause for the delay in the execution of this writ.
