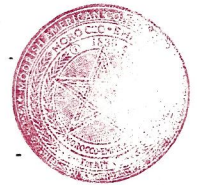

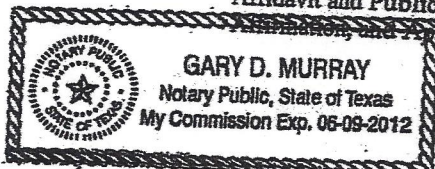

I, being previously identified by the Union States Society of North America - U.S.A. under the colorable, Ward-ship name, William Tyrone Thomas, do hereby refute the Fraud; make Public and Publish my Corrected National Name; Declare and Affirm my true, 'Proper Person Status'; and reclaim my Rightful Social and Cultural Life of the State; in accord with my Moorish Nation of Northwest Amexem / North America - acknowledging my Birthrights. Having Lawfully and Legally Obtained and Proclaimed my Moorish Nationality and Birthright 'Name and Title'; in harmony with, in association with, and in Accord with Divine Law, the Customs; and the Laws, Rules, and Usages of The Moorish Divine and National Movement; being Aboriginal and Indigenous, and bound to the North American Continent by Heritage, by Primogeniture; by Birthright; by Natural Birth; by Freehold; and by Inheritance. Declared for the Public Record, I am returning the European cognomen and fictitious misnomer back to the Colonial possessors of its pedigree. I am now Rightfully Declaring, Publishing, and Proclaiming my own Free National Name; Affirming my Actual, Rightful, and Civil 'In Full Life' Status; Conjoined to my Moorish American Consanguine Pedigree and National Honor. 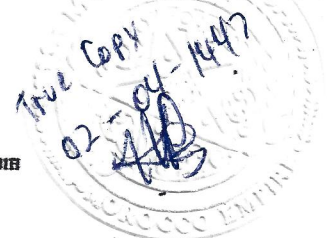

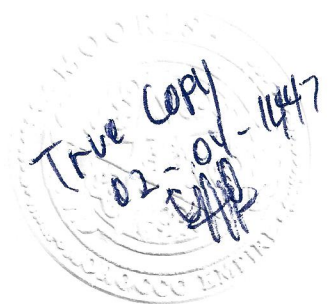

**TO ALL PUBLIC OFFICIALS, COURTS, LAW ENFORCEMENT AGENCIES,  
AND ADMINISTRATIVE OFFICERS:**

This document serves as a lawful and preemptive assertion of jurisdictional standing and a rebuttal to any claims that the diplomatic and consular functions of the Moorish Consulate of Al-Morocco, or the status of Moorish American Nationals therein, constitute a "sham" or unlawful process.





## I. Legal and Treaty Foundation of Status

We are Moorish American Nationals, descendants of the ancient Moabites, and operating in our proper person and nationality, pursuant to:

The Treaty of Peace and Friendship, 1836, between Morocco and the United States;

The Vienna Convention on Consular Relations (1963), Articles 5 and 36;

The United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP, 2007);

The U.S. Constitution, Article VI (Treaty is the Supreme Law of the Land);

The Universal Declaration of Human Rights, Articles 13, 15, and 18;

## II. Judicial Acknowledgement of Free Moors (Dred Scott, 1857)

In Dred Scott v. Sandford, 60 U.S. 393 (1857), the U.S. Supreme Court stated:

Lines 407–408:

"It is very clear that the [citizenship] provisions of the Constitution were not intended to include all those who were not of the white race... For example, the Moorish people of Morocco had been recognized as free persons under the law of nations..."

This acknowledges that Moors were historically and legally treated as free nationals, distinct from slaves or corporate chattel property, and thus entitled to the protections and dignity of international law.

## III. Comparison to Federally Recognized Tribal Nations Aspect

This parallel jurisdiction model affirms that we are not operating under "sham" pretense, but asserting rights recognized both historically and structurally, as other Indigenous Peoples and Treaty Nationals do.

#### IV. Affirmation of Rights and Lawful Standing

The Treaty of Peace and Friendship (1836) is a living, unrevoked treaty, ratified and enforceable under Article VI of the U.S. Constitution.

Consular departments are legitimate under international law, empowered to register nationals, issue diplomatic notices, and protect persons under their jurisdiction.

The Vienna Convention on Consular Relations (1963), to which the U.S. is a signatory, provides that consular authorities may maintain civil registries, assist nationals, and protest abuses (Articles 5 and 36).

The Supreme Court in *Worcester v. Georgia*, 31 U.S. (6 Pet.) 515 (1832) ruled that Indigenous nations are "distinct, independent political communities," and we operate similarly as free Moorish nationals, under divine and international law.

We reject the corporate U.S. citizen status created under the 14th Amendment, and do not consent to be regulated under colorable municipal or commercial law systems. (See: Clearfeild Doctrine)

#### V. Rebuttal to "Sham Process" Claims

A sham legal process is one:

Based on fraud, deception, or commercial exploitation,  
That lacks foundation in law, treaty, or acknowledged human rights,  
That mimics official functions without lawful authority or consent.

We are:



Not mimicking U.S. courts — we operate under our own religious and consular jurisdiction

Not engaging in commerce — we are acting in our private capacity as foreign nationals

Not corporate actors — but living people under divine and natural law, with publicly filed and declared status and offices

Our Temple and Consulate structure is formally established, with trade names recorded with the Oklahoma Secretary of State, and with all governing authority traceable to treaties, historical law, and Moorish science as restored by Noble Drew Ali (PBUH).

## VI. Conclusion and Demand for Non-Interference

We hereby notify all agents and agencies that:

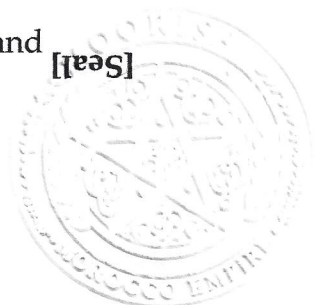
No jurisdiction exists over our persons, property, or conveyances without verified international consent.

Any attempt to interfere, penalize, or delegitimize our standing will be treated as a violation of treaty law, subject to international protest, publication, and possible redress.

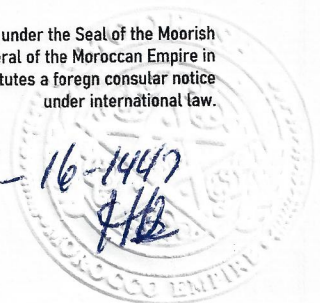

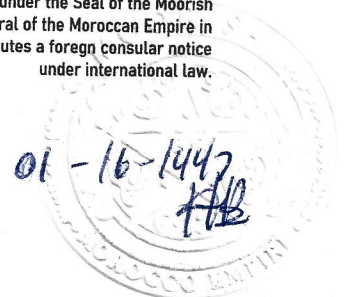

**To Whom It May Concern,**

**This Notice is issued by the Moorish Consulate of Al-Morocco, the foreign civil and diplomatic authority for Moorish American Nationals domiciled in Northwest Amexem (commonly known as North America), under the jurisdiction of the Treaty of Peace and Friendship of 1836 between the Moroccan Empire and the United States.**

**We issue this Diplomatic Protest in response to four (4) traffic citations issued on or around March 2025 to the natural man known as:**

**El Noble William Thomas-al Hasaan Bey  
Consular File Number: 1446-001  
Nationality: Moorish American  
Domicile: Tulsa County, Oklahoma Republic. NW Amexem**

**The following citations were improperly issued:**

**Ticket No. 7957785: No seatbelt in use**



**Ticket No. 7957786: No seatbelt use by minor in front seat**  
**Ticket No. 7957787: Unreadable license plate**  
**Ticket No. 7957788: Improper license display / expired plate**

### **Basis of Protest and Objection**

The named individual is not a U.S. citizen subject to commercial regulation, but a treaty-protected foreign national and is not attempting to add diversity to the United States by being included as such, but is asserting unalienable rights under:

**The Treaty of Peace and Friendship, 1836 (Articles VI, XVII, XX, XXV)**  
**The Vienna Convention on Consular Relations, 1963 (Articles 5 and 36)**  
**The Universal Declaration of Human Rights (Articles 13 and 15)**  
**The U.S. Constitution, Article VI (Treaty Supremacy Clause)**

At the time of the citations, the conveyance was:

In lawful transition from expired U.S. commercial tags to Moorish Consular registration;  
Not in commerce, not for hire, and not engaged in regulated transportation;  
Subject to consular jurisdiction as a private Moorish American conveyance, not U.S. corporate property.

### **Formal Objection & Diplomatic Protest**

**This Consulate objects to:**

**The enforcement of corporate municipal statutes against a foreign national protected by treaty;**  
**The issuance of commercial citations where no contract, harm, or commercial activity exists;**  
**The failure of the officers and agents to acknowledge known treaty rights, religious sovereignty, and consular immunity.**

We hereby protest all citations listed above and demand immediate dismissal and remedy, including but not limited to:





**Dismissal of all related charges  
Correction of public records  
A formal acknowledgment of jurisdictional error**

**Notice of Reservation of Rights**

This Notice is issued under full reservation of rights nunc pro tunc, ab initio, and pursuant to:

**UCC 1-308: Reservation of rights without prejudice;  
Vienna Convention, Article 36: Rights of communication with consular nationals;  
Hale v. Henkel, 201 U.S. 43 (1906): No compelled performance without contract.**

This document shall serve as a lawful record of diplomatic protest on behalf of a Moorish American National and may be recorded or published as necessary for remedy and redress.


