Income Documentation Checklist

- ** YOU MUST PROVIDE PROOF THAT THIS IS A COVID RELATED HARDSHIP DUE TO REDUCTION OR LOSS OF INCOME.
- **YOU MUST PROVIDE A COPY OF YOUR LEASE OR A COPY OF YOUR MORTGAGE SHOWING RESIDENCE.
- **YOU MUST PROVIDE A STATEMENT FROM YOUR LANDLORD OR A STATEMENT SHOWING DELIQUENCY.

Employment Income and Other Income:

- 1 year most recent tax return (1st 2 pages of form 1040 only)

(Medical assistance, food stamps, and child care assistance are not considered for income qualifications and will not be needed to document)
- Rental Income: a signed agreement between the landlord and the tenant including rental dates and price

Self-Employment Income:

- Most recent 3 months' worth of income and expenses for your business

Unofficial Transcript:

- If a member of the household is age 18 or older and is enrolled in school full-time while receiving income, provide a copy of an unofficial school transcript.
