Sl. No.	The school is directed to ensure that:
1	The school has not arranged the biology and chemistry labs separately as per the SoPs. The labs are arranged in common room without partition and proper infrastructure as per the guidelines notified vide circular No. 11/2022. The school is directed to arrange the labs in the separate rooms of recommended size and upload the compliance with videography within 03 months on SARAS portal.
2	As reported by the IC, the School has not appointed the Special Educator and the Wellness Teacher and has undertaken to appoint the same on priority. The appointment letters of wellness teacher and special educator be uploaded with compliance within 03 months on SARAS portal.
3	The school is directed to arrange the well equipped Composite Science Lab in compliance with the Board guidelines as notified vide circular no 11/2022. The composite science lab is mandatory at secondary level. The compliance should be uploaded with videography within 03 months on SARAS portal.
4	The CwSN facilities have not been arranged as per the board guidelines and SoPs. School has arranged only one common CwSN toilets which is not adequate and sufficient. School is directed to follow the circular no 11/2024 dated 09.08.2024 and arrange the proper CwSN facilities including the ramp/lift to access the upper floors. The compliance should be uploaded with videography within 03 months on SARAS portal.

5	The general Toilets and washrooms have not been properly arranged with hygiene and cleanliness in compliance of rule 4.7.2 of the Affiliation Bye-Laws.
6	The school is directed to ensure that all essential valid documents are available under the head Mandatory Public Disclosure (as per Annexure – IX) on school's website at all time and the link of certificates should be remain functional and submit an undertaking in this regard on its letter head duly signed by the principal and manager of the school in the compliance within 03 months.
7	The school shall submit an undertaking to upload all requisite information regarding students, teachers, and infrastructure details available in the school on the UDISE and OASIS Portals. The registration of the students in classes XI and XI shall be conditional on the school providing complete information on the UDISE and OASIS Portals.
8	As per the recommendation of NEP, the school shall ensure the participation of its students in the Structured Assessment for Analyzing Learning (SAFAL), an exam conducted by the Board every year. This exam, designed to assess and enhance students' learning, is a valuable initiative for their holistic development, as per the guidelines issued by the Board vide circular no: Acad-49/2024 dated 26 June 2024.
9	The school will ensure the Holistic Progress Card (HPC) is used for the foundational stage according to the guidelines issued by the Board via notification no. CBSE/Director (AcadAssessment)/2023 dated 27.12.2023.
10	The school shall ensure that all teachers undergo at least 50 hours of Continuous Professional Development (CPD) every year, vide notification no. 16/2021 dated 24.09.2023, out of which 25 hours should be from COE, CBSE, Pune.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The above sanction is subject to fulfillment of following conditions:-

- 1. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
- 2. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- 3. The School is required to apply on online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school should go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy there of for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school is required to renew mandatory certificates from time to time.

- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
- 7. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
