National and State Perspectives on Major Issues Impacting the Security of K-12 Educational Assessment in 2020-21

The Future of Test Security

The testing industry and professional test cheats are engaged in a never-ending game of chess, in which each entity is not only responding to vulnerabilities which have been identified and exploited by their opponent, but are needing to anticipate future plans of attack and develop effective prevention, deterrence, mitigation, and detection strategies. Developments in new technology continue to introduce new avenues for examinees to steal and share test content, and for programs to develop tests which are more cheat-resistant and to execute more effective and comprehensive security response plans. The global pandemic has forced even greater changes in the testing industry, and while it is unclear which of these changes will persist beyond the current circumstances, it is already clear that many of the changes will be lasting. In this panel discussion, leading security authorities on test design, development, test administration, and cheating detection will share their thoughts about where the field is heading, what new threats we might expect, and what we must be doing to ensure the security of our future assessments.
