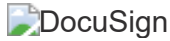

My name nor Business Makeover should be on this email. I communicated with [REDACTED] and was aware he was going to be sending correspondence, however, the correspondence is not to be addressed as the proceeds we're not sent to Business Makeover. Business Makeover.

The proceeds were sent to MASTERS BUSINESS ALLIANCE TRUST and should be addressed to Brendon directly.

[REDACTED] and I had a side agreement that I will attempt to indemnify thr proceeds to [REDACTED] directly, since Brendon does not have the capability to do at the present moment.

Please allow this to confirm our telephone conversation June 28, 2023 and a second conversation with Anthony on July 9, 2023 wherein we discussed the return of the principal payment in the amount of \$20,000.00 USD made by [REDACTED] to MASTERS' BUSINESS ALLIANCE TRUST.

According to the Consulting and Transfer Agreement between [REDACTED] and MASTERS' BUSINESS ALLIANCE TRUST signed March 6, 2023, the principal amount of \$20,000.00 was to be deposited into a Brokerage account with The Traders Domain platform. To date, [REDACTED] has not been provided any receipts, proof of account transfers or any Brokage account balances related to the transfer of funds as described in the Contract. MASTERS' BUSINESS ALLIANCE TRUST has not provided proof that they have honored the Consulting and Transfer Agreement by transferring said funds.

The Trader's Domain brokerage account in which the \$20,000.00 was to be transferred into, is currently not active and has not been active in the past 4 months.

[REDACTED] is displeased and not accepting of how the Contract has not been honored nor of the continued delays. [REDACTED] expects the return of the principal amount of the \$20,000.00 USD within 5 business days of the date of this notice and no later than 4:00 P.M. CST Tuesday, July 18, 2023.
