MASTERS' BUSINESS ALLIANCE TRUST

This Consulting Agreement (the "Agreement" or "Consulting Agreement") states the terms and conditions that govern the contractual agreement between MASTERS' BUSINESS ALLIANCE TRUST having its principal place of business at 8240 Mid Cities Blvd North Richland Hills Texas 76180 (the "Trust"), and [REDACTED] (the "Client") who agrees to be bound by this Agreement.

WHEREAS, the Trust offers consulting services in the field of General Business Administration and Market Data Information, and offers the ability for a client to transfer funds to brokerage accounts that the Trust already participates in.

Brendon never was able to show proof on any internal transfer of client (Me) funds to brokerage accounts.

NOW, THEREFORE, In consideration of the mutual covenants and promises made by the parties hereto, the Trust and the Client (individually, each a "Party" and collectively, the "Parties") covenant and agree as follows:

1. Term

Agreement started March 6, 2023.

This Agreement shall begin on March 6th 2023 and continue for one calendar year.

1 Either Party may terminate this Agreement for any reason with three days written notice to the other Party.

When terminating this agreement in July of 2023, nowhere does it state in this agreement that I am not entitled to having the \$20k returned.

2 Clauses 7, 8, and 9 shall be binding and in full effect in perpetuity, without recourse.

2. Services

The Trust agrees to render any information that may be vital to the goals of the client, as well as to take into custody funds for the purposes of an internal transfer for foreign exchange brokerages, including but not limited to The Traders Domain.

\$20,000 USD was wired to Brendon's trust account from my account but he never made the internal transfer into my Trader's Domain brokerage account as agreed. Instead, used the money for his personal interests.

3. Transaction

The client agrees to Transfer \$20,000 USD to the following account for deposit into the following brokerage account:

4. Intellectual Property Rights in Work Product

The Parties acknowledge and agree that the Client will hold all intellectual property rights in any work product resulting from the Consulting Services including, but not limited to, copyright and trademark rights. The Trust agrees not to claim any such ownership in such work products intellectual property at any time prior to or after the completion and delivery of such work product to the Client.

5. Confidentiality

The Trust shall not disclose to any third party any details regarding the Client's business, including, without limitation any information regarding any of the Client's customer information, business plans, or price points (the Confidential Information), (ii) make copies of any Confidential Information or any content based on the concepts contained within the Confidential Information for personal use or for distribution unless requested to do so by the Client, or (iii) use Confidential Information other than solely for the benefit of the Client.

6. Noncompetition

During the term of this Agreement and for 3 months thereafter, the Trust shall not engage, directly or

indirectly, as an employee, officer, manager, partner, manager, consultant, agent, owner or in any other capacity, in any competition with the Client.

7. Nonsolicitation of services

Why is Brendon-Jackson:Jones seeking indemnity here? Trying to protect himself?

The Client agrees to indemnify Brendon-Jackson: Jones from any personal liability, and that if any disagreement may arise between the parties that the Client will seek the Trust as an entity for relief that may be sought. The Client agrees that the Trust did not solicit the Client in any capacity whatsoever. The Client is aware that the Trust is not a Securities Broker Dealer, and agrees to waive any rights or remedies that may be found in State or Federal Statutes in regards to potential misunderstanding, mistake, error, or claim the client may seek against the Trust.

8. Nonsolicitation of participation

The Client agrees explicitly that they were not solicited into any brokerage or trading program and that they are entering into the brokerage platform completely on their own accord. The Client agrees to indemnify the Trust for any claim the Client may have against the brokerage.

Client was not solicited by Masters' Business Alliance Trust? Was client solicited by Brendon and Anthony on behalf of Business Makeover, LLC? Yes

9. Indemnification

The Client agrees to indemnify, defend, and protect the Trust from and against all lawsuits and costs of every kind pertaining to the Client's business including reasonable legal fees due to any act or failure to act by the Client based upon this agreement.

Again, Brendon tries to protect himself and his trust.

10. No Modification Unless in Writing

No modification of this Agreement shall be valid unless in writing and agreed upon by both Parties.

11. Applicable Law

This Consulting Agreement and the interpretation of its terms shall be governed by and construed in accordance with the laws of Equity and Trust, subject to the exclusive jurisdiction of the courts of Equity and Chancery. This contract is protected by Article 1 section 10 Clause 1 of the Constitution for the United States

In the previous slides, you can see Brendon created this Transfer Agreement between Masters' Business Alliance Trust and me, but never once when corresponding with Brendon did I get an email from Masters' Business Alliance Trust or any of its affiliate companies. Instead all email was communicated through his email brendon@businessmakeoverllc.com.

The docuSign account he used to execute this agreement was Anthony Curtis' and Business Makeover, LLC's DocuSign account.

Why did Brendon not send any correspondence from his own trust email or use a DocuSign account associated with Masters' Business Alliance Trust if the agreement was between his trust and me? To remove liability?
