Declaration of Intent to Form New California State

The People of these counties declare their Constitutional Right under Article IV, Section 3 and 4 to split California to form two states; New California and Old California. This action is a political solution to a spiritual problem namely, the corruption in Sacramento. The People of these counties have no other recourse left to them other than the bullet box.

In fact, it may be their only ability to remain Citizens of the United States and not refugees under U.N. "protection" as the Governor has openly showed support for La Raza's movement to return California to Mexico known as Calexit. - He supports a Jesuit Catholic World View and he has met with the Pope to force the people of these counties to adopt the restrictions recommended by the Pope.
- He supports indoctrinating our children to accept Islam, homosexuality, transgenderism, multiculturalism, and even pagan earth worship. He allows this against the will of the People.
- He disallows parents the ability to determine if their child should be vaccinated. Instead he has forced vaccinations on school children.

Article IV of the Bill of Rights: "The right of the People to be secure in their persons, houses, papers, and effects against unreasonable searches and seizures, shall not be violated, and no Warrants shall issue, but upon probable cause, supported by Oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized."

 He allows State police to conduct no-knock raids on individuals for the purpose of gun confiscation under certain conditions thereby abrogating these individuals Constitutional Rights under Article II and Article IV.

Article V of the Bill of Rights: "No person... (Shall) be deprived of life, liberty, or property, without due process of law..."

• Through no-knock raids he deprives some citizens of life, liberty, and property without due process of law.

Article XIV, Section 1. Of the Bill of Rights: "All persons born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they reside. No State shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States; nor shall any State deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws."

- He treats illegal immigrants like they are citizens of the State of California and the United States through his giveaway of public services. These services are paid by taxpayers and should be reserved for citizens of the State of California.
- He treats illegal immigrants like they are citizens of the State of California and the United States by giving them in-state tuition. He then gives them priority to scholarships. Thereby harming citizens of the State who should have the priority access to in-state tuition and scholarships.
- He allows an open border with Mexico and impedes the United States government enforcing immigration laws.
- He has declared California a sanctuary state allowing criminals who are deported to return.

- He has refused to cooperate with the United States government to investigate election and voter fraud.
- He has released criminals from prison.
- He has allowed criminals to immigrate illegally into California jeopardizing not only the State of California but the rest of the nation.
- He has allowed marijuana groves that threaten the citizenry and poison and destroy the environment.

Article IV, Section 4 of the United States Constitution: "The United States shall guarantee to every State in this Union a Republican Form of Government, and shall protect each of them against Invasion; and on Application of the Legislature, or of the Executive (when the Legislature cannot be convened) against domestic Violence."

- He has signed legislation that completely destroys a Republican Form of Government in the State of California.
- He impedes the Federal government in performing its duty to the People of these counties to provide protection from invasion of criminals and terrorists; and he illegally claims jurisdiction over the United States government in these matters.
- He invites domestic violence by allowing and supporting violent groups such as La Raza,
