Our major accomplishments in this area are the high school graduation rates of our 8th grade graduates (100% for the Class of 2025, Nativity Class of 2021) and post-secondary matriculation rates of our 8th grade graduates (73% of Class of 2024, Nativity Class of 2020).

The middle school program is another of our three largest program services. Our major accomplishment in this area is the retention of our school administrators and teaching staff from last school year to this school year and the addition of a qualified, experienced teacher in a position we have been unable to fill for the previous 2 school years.

Student enrollment increased by 6 students from 24-25 school year to the 25-26 school year, which is an increase of above 10% of enrollment, the strategic plan annual enrollment growth target. Teacher retention from the 2024-2025 to the 2025-2026 school year was over 90% along with filling an over 2 year long science content area teaching vacancy with a quality candidate.
