We Honor a Beloved Founder: Sr. Paula Kleine-Kracht, OSU

Nativity Academy was founded in August 2003, by Fr. Tim Hogan, former pastor of St. Boniface parish, Fr. William Fichteman, former pastor of the Cathedral of the Assumption, and administered by Sr. Paula Kleine-Kracht OSU. Nativity Academy at St. Boniface was established as an independent private middle school in the Catholic tradition to educate children from the Clarksdale housing project across the street.

Described as a “trailblazer in Catholic education,” Sister Paula transformed the lives of countless students in Louisville. In her 50 years in education, Sr. Paula was principal of Sacred Heart Academy from 1994 to 2001, building the school’s very successful International Baccalaureate (IB) Programme. She also served as principal of Angela Merici High School from 1980–84 when it merged with Bishop David High School to form co-ed Holy Cross High School.

Sr. Paula taught at Sacred Heart Academy and Angela Merici High School in Louisville, and at Cardinal Newman High School in Columbia, S.C. in the 1970s; was an adjunct professor at Roosevelt University in Chicago in the 1980s, assistant professor at the University of Delaware in the 1990s, an adjunct professor at Bellarmine University from 2011-2013, and a teacher in the Jefferson County Public Schools Adult Education program from 2013 to 2014. She served as Councilor on the Leadership team of the Ursuline Sisters from 2014 to 2020.

Sr. Paula received the Msgr. Felix Pitt Award for principals in 1983; in 2001, she was honored with both the Archdiocese of Louisville’s Catholic Secondary Education Award and induction into the Distinguished Gallery of Graduates of Bellarmine University; and in 2016, she was one of seven alumni recognized by the Catholic Education Foundation of the Archdiocese of Louisville at the annual *Salute to Catholic School Alumni*

celebration. Sr. Paula also received an Honorary Alumnus award from Holy Cross High School in 2018.

Up until her death, Sr. Paula still regularly attended all Nativity fundraisers, luncheons, and graduations, was a mentor to so many, and the catalyst to countless supporters through the years. Sr. Paula died on October 31, 2025. While we feel a major loss to our community, we are blessed with the promise to make her legacy live on for years to come. Thank you Sr. Paula for your vision, faith, and dedication.

Sr. Paula was inducted into Nativity Academy’s Hall of Fame in 2023, and Nativity named a scholarship in her honor that same year. Donations can be made in Sr. Paula’s honor for the scholarship funds that support our graduates’ Catholic high school education.





Dear Nativity Academy Family,

Each year in the liturgical season of the Nativity of Our Lord, I try to reflect in a special way on the theological significance to our school's name. A nativity is the process or circumstance of one's birth, and The Nativity, of course, is the birth of Jesus Christ. I can't help but be in awe of the circumstances and process of Jesus' birth: a poor, traveling family who was rejected in their hometown of Bethlehem to the point where God's Son was birthed in a stable alongside livestock. Then not long after, they take off in haste to live as refugees in Egypt because God told Joseph in a dream to do so. Yet to and through the fulfillment of God's mission with the Incarnation of his Son, Joseph and Mary remained filled with faith and eyes fixed on God's plan.

With Sr. Paula's passing on October 31, this year's Season of The Nativity gives me particular pause surrounding the circumstances and process of our Nativity Academy at St. Boniface's beginning. The stories from those beginning days and years were certainly not without their difficulties, and yet, our founders, founding board members, founding teaching staff, and first school families, kept the faith with their eyes fixed on God's long-term plan for our school.

The Ursuline Sisters and Xaverian Brothers, our founding sponsoring congregations, are well known for their dedication to excellence in every facet of the operation of their schools. This year's Nativity Annual Report carries on this legacy, demonstrating to you, our stalwart supporters, that we are staying true to our commitment to excellence in pursuit of our mission: providing Catholic education for a foundation to a life without limits.

Know of our deep gratitude for all you do to keep Sr. Paula's vision of Nativity Academy at St. Boniface thriving. Even in the most difficult of challenges, we will lean into the principles of excellence and faith. Thank you for your investment in us.
