Nativity Academy has experienced both an enriching and spectacular 2018-19 year. This past year we celebrated our 15th year of mission-driven Catholic Education in the urban core of Louisville as we serve students and families who have been mostly underserved.

Our signature **Graduate Support Program (GSP)**, once again achieved 100% High School graduation rate and seven of our former students earned FULL college scholarships and an additional four students achieved academic scholarships to their respective colleges/universities.

The **Extended Enrichment Program (EEP)** served more students than ever before with unique, safe, quality *Out of School Enrichment Experiences* through several new and returning Community Partnerships.

These enrichment programs provide social capital from which the students draw as they grow into the person they dream to be. We Implemented the NWEA MAP standardized testing at Nativity and saw our students work hard to meet and/or exceed their expected goals.

The completion of the Fr. Tim Hogan Plaza provided a fitting tribute to one of our founders while enhancing our entrance, adding greenspace and providing functional parking. Thanks to all who made this project a reality!

We are proud of our accomplishments and extremely grateful to each of you, our supporters, for having the faith and confidence to support our mission in so many ways.

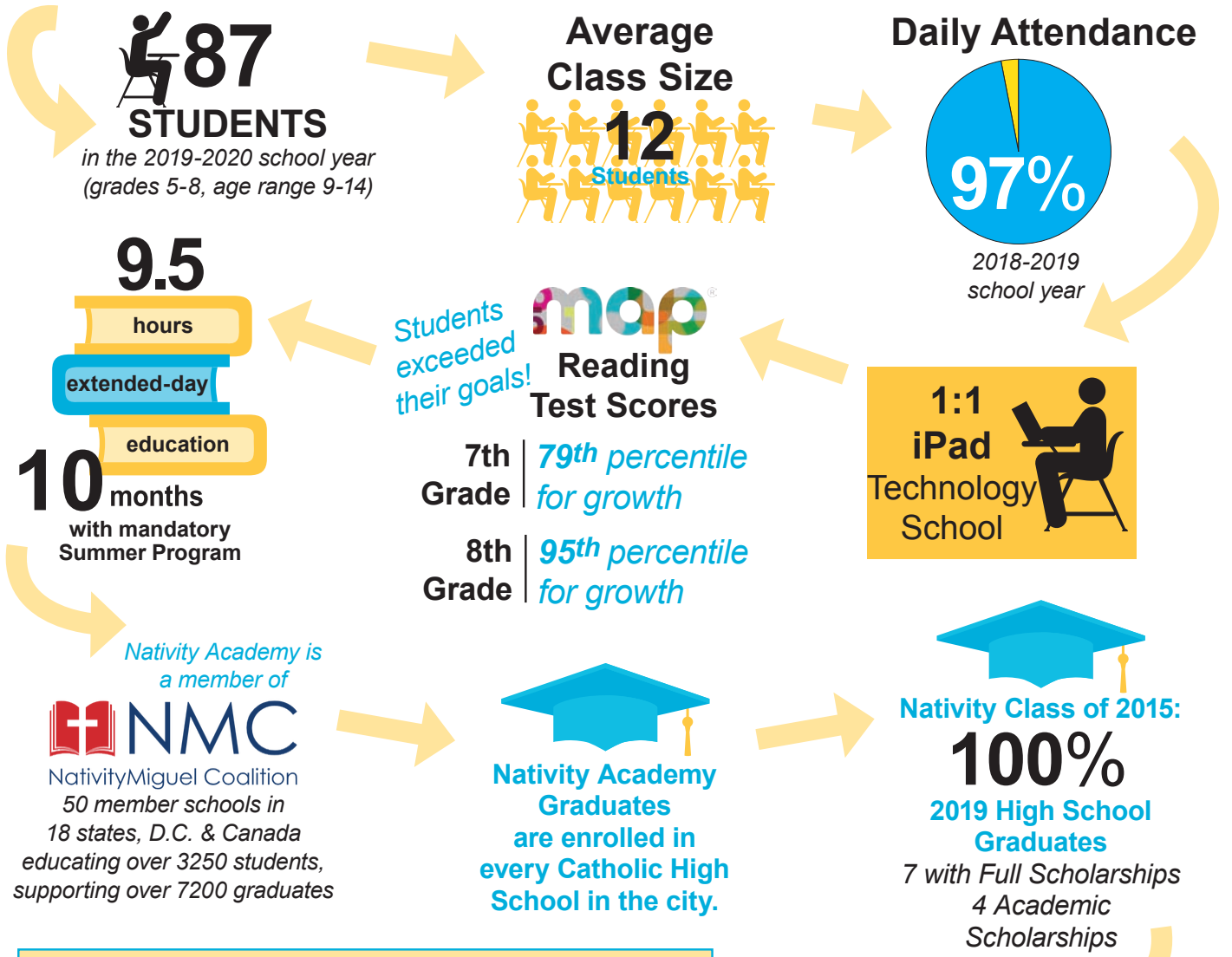

Nativity by the numbers

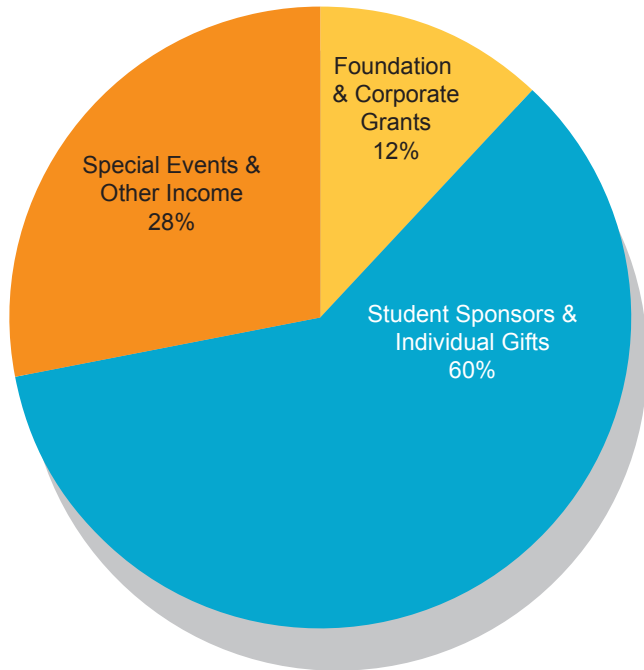

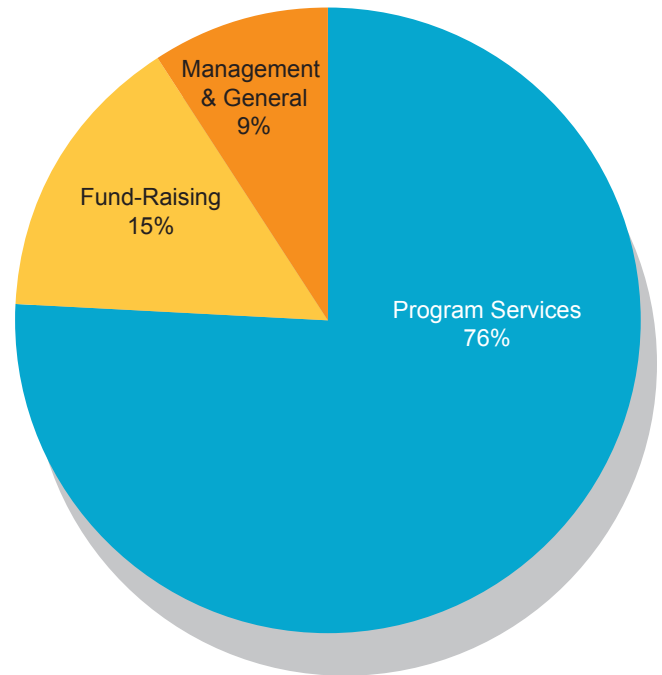
