Your VOTE COUNTS as we take a look at revising our Aerie #143 By-Laws. The By-Laws Committee needs your help as Aerie #143 governing body, to plan and promote our path forward.

The following By-Law changes will be read at our regular Aerie Meetings; on February 25th, 2025, March 11th, 2025 and March 25th, 2025. At the March 25th, 2025 meeting, we will discuss and vote on the purposed changes.

Please attend March 25th, 2025 Aerie meeting and exercise your membership voting rights.

OLD: Section 2.4 Tellers shall be appointed by the Worthy President. (Presiding Officer)

NEW: Section 2.4 Tellers shall be appointed by the Worthy President or the Presiding Officer.

OLD: Section 3.1 The fee for membership is initiation shall be \$20.00.

NEW: Section 3.1 The fee for membership by initiation shall be \$20.00.

OLD: <u>Section 3.5</u> Former members of an Aerie wishing to re-enroll win this Aerie will pay a fee of \$20 plus annual dues in advance of \$42.00. One half of the Re-enrollment (\$10.00) will remain in this Aerie for work involved.

NEW: <u>Section 3.5</u> Former members of an Aerie wishing to re-enroll in this Aerie will pay a fee of \$20.00 plus annual dues of \$52.00.

OLD: <u>Section 5.1</u> Dues of Non-Beneficial Members and Re-Enrolled members shall be \$42.00 per year, payable in advance.

NEW: <u>Section 5.1</u> Dues for Non-beneficial, Re-enrolled, and Transferred members shall be \$52.00 per year, payable in advance.

OLD: Section 5.1(a) Dues for members who transfer shall be \$42.00 per year.

NEW: Section 5.1(a) DELETE

OLD: Section 5.2 Dues of Non-beneficial members shall be divided annually among the various funds as Follows:

- A) Benefit Fund \$14.00
- B) Social Fund \$13.00
- C) Building and Maintenance Fund \$15.00

NEW: <u>Section 5.2</u> Dues of Non-beneficial, Re-enrolled and Transferred Members shall be divided among the various funds as follows:

A) Benefit Fund \$22.00
B) Social Fund \$20.00
C) Building and Maintenance Fund \$10.00

OLD: <u>Section 5.2(a)</u> The fourteen (\$22) reserved to pay the yearly Per Capita Tax will not be prorated. The Twenty-Eight (\$28) for the Pikes Peak Aerie shall be prorated according to the month the member is initiated or re-enrolled.

NEW: <u>Section 5.2(a)</u> The \$20.00 reserved to pay the yearly Per Capita Tax will not be prorated. The \$30.00 for Pikes Peak Aerie shall be prorated according to the month the member is initiated, re-enrolled or transferred.

OLD: Section <u>5.3</u> Dues for Dual Members shall be \$42.00 per year payable in no event for the period longer than the period for which the member has paid his dues in advance in his original Local Aerie.

NEW: <u>Section 5.3</u> Dues for Dual Members shall be \$52.00 per year payable in no event for the period longer than the period for which the member has paid his dues in advance in his home Aerie.

OLD: Section 5.4 Dues for Dual Members shall be divided annually among the various funds as follows:

- A) Social Fund \$26.00
- B) Building and Maintenance Fund \$16.00

NEW: Section 5.4 Dues of Dual Members shall be divided among the various funds as follows:

A) Social Fund \$34 B) Building and Maintenance Fund \$18

OLD: SECTION 6.4 INTENTIONLLY LEFT BLANK

NEW:

Section 6.4 DELETE

OLD: <u>Section 6.6</u> Whenever the Aerie has a function of any kind, a fundraiser or a private event of any kind there shall always be at least one Trustee or more if possible present and they shall stay until said function, fundraiser or a private event has concluded and to see if that the Aerie is put back in proper order, the same day/night or that other arrangements have been made to do so.

NEW: <u>Section 6.6</u> Whenever the Aerie has a function of any kind, a fundraiser, or a private event, there shall be at least one Trustee, more, if possible, present always. They shall stay until the function, fundraiser or private event has concluded. They should ensure that the Aerie is put back in proper order the same day/night or that other arrangements have been made to do so.

OLD: <u>Section 8.3</u> When the Auxiliary has a funeral dinner for a member in good standing or a member of their immediate family the Aerie will supply the meat for the dinner not to exceed \$75.00 dollars unless approved by floor action at a regular scheduled meeting or vote of the officers if there is not a regular schedule meeting in time.

NEW: <u>Section 8.3</u> When the Auxiliary has a funeral dinner for a member in good standing or a member of their immediate family, the Aerie will supply the meat for the dinner in an amount not to exceed \$150.00 unless approved by floor action at a regularly scheduled meeting or by vote of the officers, if there is not a regularly scheduled meeting in time.

NEW: <u>Section 8.3(a)</u> Immediate family will be defined as Spouse, Father, Mother, child, sister, brother, Grandparents, Grandchildren, and Greatgrandchildren.

NEW: <u>Section 8.4</u> The Aerie and Auxiliary Funeral Dinner Chairman shall work jointly to arrange and set up said dinners.

OLD: Section 9.5 INTENTIONALLY LEFT BLANK.

NEW:

Section 9.5 DELETE

OLD: <u>Section 9.8</u> The Aerie shall appoint a Bingo Bookkeeper which has a Bingo Manager License, and the duties will be paperwork for Bingo and Pull Tabs. For the performance of the duties the clerk will receive \$75,000 in a Bingo Session.

NEW: <u>Section 9.8</u> The Aerie shall appoint a Bingo Bookkeeper who must have a Bingo Manager License. The duties will be paperwork for Bingo and Pull-tabs, including the Quarterly Report. For the performance of these duties the Bingo Bookkeeper will receive \$75.00 a Bingo Session.

OLD: Section 9.7

Additional Help – not to exceed minimum wage per hour, with time and a of half for all hours over 40 a week.

NEW: Section 9.7

Additional Help – not to exceed Colorado minimum wage per hour, with time and a of half for all hours over 40 a week.

OLD: <u>Section 9.9</u> .... transportation to and from the sessions by the most direct route equaling the bus or air fare.

NEW: Section 9.9 .... transportation by the most direct route equaling the lessor of mileage or air fare.

OLD: <u>Section 9.10</u> Whenever the Aerie, by properly adopted resolution, sends its accredited representative to the Grand Aerie Convention, they may be allowed a sum of \$600.00 plus registration fee and if traveling by automobile.

NEW: <u>Section 9.10</u> Whenever the Aerie, by properly adopted resolution, sends its accredited representative to the Grand Aerie Convention, they may be allowed a sum of \$750.00 plus registration fee and transportation by the most direct route equaling the lessor of mileage or air fare.

OLD: Section 9.10a The Junior Past Worthy President shall be the accredited representative to the Grand Elect some other Pas Worthy President or Ten Yar Secretary in his place. If no such is available, the Worthy President of the local aerie may be elected as its accredited representative and in such case, he may cast the votes of the local aerie.

NEW: Section 9.10a The Junior Past Worthy President shall be the accredited representative to the Grand Aerie convention. If they cannot attend another Past Worthy President or Ten-Year Secretary may take their place. If no such is available, the Worthy President of the local Aerie may be elected as its accredited representative.

OLD: Section 9.12 A Past Worthy President of the Aerie who attends the Business Sessions....

NEW: Section 9.12 Any member of the Aerie who attends the Business Sessions...

OLD: Section 12.1 .....to be paid from the General Fund.

NEW: Section 12.1 .....to be paid from the Social Fund.




