LANDSCAPING UPDATE

2020 Activities:

- •Green areas management continued (areas include: vegetation around Vuemont signs on 164th and SE 46th, median along SE 46th, bump-outs on 171st, 171st cul-de-sac green belt, and dip area.
- 3-4 rotations of annuals planted at the two Vuemont signs.
- •Irrigation system maintained and winterized: valve & clock upgrade.
- •Aspens on SE 46th St: aphid treatment suspended past 2 years because of the negative impact on beneficial insects. Aphids have not returned so treatment will be suspended another year.

Special Project:

- •First annual Green Debris Pickup day in April.
 - 13-14 residences participated (10%)
- We hope to repeat in 2021 and encourage more participation.

Potential Projects for 2021:

- •Increase planting rotation at the two Vuemont signs and bump-outs.
- •Mulch bump-outs on 171st for weed suppression.

Misc:

•Pet waste station management continues in 2 locations, includes monthly waste pick-up and waste bag replenishment.

VEGETATION MANAGEMENT

- Hired consulting firm to assess greenbelt dip for potentially hazardous trees as required by City of Bellevue. 6 trees were identified as hazardous (and slated for removal).
- Submitted for and secured permit from City of Bellevue to remove 6 trees in the greenbelt dip.
- Communicated with neighbors regarding tree work to be done.
- Tree removal was completed on November 6.
- Replanting will be done in early spring (one larger cedar tree for each tree removed)
- Will have work reinspected once trees are replanted.
- Next year we will spray for blackberries and work on one or two zones, depending on funds available.

FINANCIAL REPORT

Financial position as of November 30, 2020

- <u>Cash</u> in the Bank \$69,377
- We expect to end 2018 with a cash balance of about \$68,500
- <u>Dues</u> are \$300/year for VM 1 and 2.
- VM3 and Eastmont are not part of our HOA but we assess them for their share of landscaping.
- All dues have been collected except five (absentee homeowners)
- The Board continues to believe it is prudent to have reserves available for future major costs such as replacement of the sprinkler system.
- We will have an online portal to pay dues up and running by January when statements are sent out!
