LANDSCAPING UPDATE

2021 Activities:

- Green areas management continued (areas include: vegetation around Vuemont signs on 164th and SE 46th, median along SE 46th, bump-outs on 171st, 171st cul-de-sac green belt, and dip area).
- Irrigation system maintained and winterized: valves replaced

Special Projects:

- Significant tree trimming and ivy removal near Vuemont signs
- Bump-outs on 171st mulched and maintained
- · Grass under birch trees thatched, reseeded and top covering
- Several valves replaced on sprinkler system

Misc:

• Pet waste station management continues in 2 locations, includes monthly waste pickup and waste bag replenishment.



VEGETATION MANAGEMENT

- Reinspection of replanted areas south of greenbelt dip where hazardous trees were removed last year.
- Met with City of Bellevue to discuss ongoing Vegetation Management Plan maintenance.
- Hand work to be done next month to remove blackberries on hillside to encourage
 native vegetation to thrive in area. This work was postponed by weather this
 summer and lack of availability of contractor. We will be permitting and doing
 additional view corridor windowing, removal and replanting this year.
- Hillside stable and thriving.
