2019 Activities:

- Green area management continued.
- Three rotations of annuals planted at the two Vuemont signs.
- Bump outs on 171st mulched for weed control.
- Irrigation system maintained and winterized.
- Aspens on SE 46th St: we suspended aphid treatment last year due to the

negative impact the chemicals have on bees and other beneficial insects.

Since the aphids were not an issue in 2019 we will suspend the treatment

for another year.

Special Projects:

- Median along SE 46th St updated with nandina and dwarf hugo pine.
- River rock added to bump outs on 171st to minimize wash-out that occurs during large storm events.

Potential Projects for 2020:

• Increase planting rotation at the two Vuemont signs and bump-outs.

Misc:

 Pet waste station management continues in 2 locations, includes monthly waste pick-up and waste bag replenishment.

Trees/Vegetation Management:

8:21 – City required replanting:

- Secured approval from City of Bellevue for Vegetation Management Plan for next five years.
- Completed view trimming in May under our Vegetation Management Plan in 4 major zones.
- Replanted in November (3 planted for every tree removed) with native vegetation recommended by the City of Bellevue for hillside stability.
- Planning an assessment of greenbelt zones where trees are close to homes (south of greenbelt dip and far west zone on rim).
- Hillside stable and thriving.

Financial position as of November 30, 2018:

- Cash in the Bank \$71,286
- We expect to end 2018 with a cash balance of about \$68,000

- Dues are \$300/year for VM 1 and 2.
- VM3 and Eastmont are not part of our HOA but we assess them for their share of landscaping.
- All dues have been collected except 2 VM3 owners.
- We increased our spending on landscaping by a modest amount.
- The Board continues to believe it is prudent to have reserves available for future major costs such as replacement of the sprinkler system.
- Dues for 2020 will probably remain the same as 2019.
- We hope to have an online portal to pay dues up and running by January when statements are sent out!
