I, Howard Mann, declare under penalty of perjury as follows:

- 1. My name is Howard Mann. I am over 18 years of age, of sound mind, and am competent to make this Declaration. The evidence set forth in the foregoing Declaration is based upon my personal knowledge unless expressly stated otherwise, and if called and sworn as a witness, I could and would testify to each of the facts set forth herein.
- 2. I am currently 78 years old and reside with my wife at my home in in Encino, California.
- 3. On or about March 17, 2023, I received a call from an individual using the number (803) 962-3077, who claimed to be from the Department of Water and Power. The caller stated my utility bill was overdue and threatened to shut off my water and power if I did not make an immediate payment. This person had detailed information about me, including my account number, address, name, and a plausible amount consistent with previous bills due. Convinced by the caller, I was instructed to resolve the issue using cryptocurrency.
- 4. I was instructed to go to a Bitcoin ATM to deposit cash, purchase Bitcoin, and transfer it as the required payment using a QR code provided to me. Believing that I was sending payment to my legitimate utility service provider, I used a "Coinhub" Bitcoin ATM located at 19558 Ventura Boulevard, Tarzana, California 91356.
- 5. After I deposited cash, and following these steps, I was informed that the payment had not been received and was directed to make additional deposits. This happened several times and led me to repeatedly deposit cash at the Bitcoin ATM.
- 6. The individuals purporting to represent the Department of Water and Power, with whom I communicated throughout this entire scheme, identified themselves as Sean Moore and Miranda Gomez.
- 7. Upon realizing that I had not missed any payments to the Department of Water and Power and that the money I transferred had been stolen, I reached out to Inca Digital, a cryptocurrency investigation firm, to trace my transactions. Before the investigation by Inca Digital and counsel, I
