Treasurer's Report: Donna DeFiore reported that for August 2025, a <u>Beginning Balance</u> of \$5,388.55; <u>Total Receipts</u> of \$1,139.31; and <u>Total Expenses</u> of \$4,157.09 - leaving an <u>Ending Balance</u> of \$2,370.77. The report was filed for audit.

Michelle Pozzie - candidate for Sarasota County School Board District 5 to replace Karen Rose, was appointed by Gov. DeSantis to fill the vacancy of Tim Enos. She expressed determination to reimagine the educational system and fulfill the Mission Statement for Sarasota County Schools: Engage, elevate, and empower every student, every day!
