Call to Order: President Terry Angley called the meeting to order at 11:56 am.

Announcements:

Michelle Pozzie announced two protest demonstrations addressing a speaking engagement by Anthony Fauci on April 14th. The first rally, sponsored by the group 'V is for Vaccine' [https://www.visforvaccine.com], will be at 8:30am at the Van Wezel Performing Arts Center in Sarasota.

Immediately following the 8:30am rally, in conjunction with The Hollow Alliance, Michelle has arranged a separate protest rally a few blocks away at Five Points Park, 1 Central Ave, Sarasota, Florida. This second rally should last from about 11am-3pm.

On the docket to speak in behalf of informed consent, real transparency, and medical ethics will be venerable patriots such as: State Surgeon General of Florida, Joseph Ladapo; Attorney General James Uthmeier; president and co-founder of the Front Line COVID-19 Critical Care Alliance (FLCCC), Dr. Pierre Kory; and outspoken biologist Bret Weinstein. Program Speaker:

We were pleased to hear from Staff Sargent Sheila Gallo [Retired USAF], co-founder and director of operations for Lotus Shadows - a local rescue and advocacy group for survivors of human trafficking. Their organization uniquely comprises a dedicated team of military veterans to include former special operators, search and rescue specialists, former law enforcement, trauma specialists, and other health care professionals.

They rescue trafficked children across the United States and internationally. Sheila shared her career and fascinating family experiences, including her Persian background under the Shah of Iran, and having been an operational strategic manager in the U.S., working logistics for billions of dollars worth of nuclear weapons - working 'in the shadows'.

Her husband, Matt, having been expelled from the military for not accepting Covid MNRA injections, heard about America's Future and General Mike Flynn. Thus they found their current true path for saving America's children and fighting human trafficking. Those responsible for rescuing children were just not doing it. Denials from local officials make the problem worse because people stop looking. The National Hotline may be great, but it is not fast enough. In 50% of cases, kids are being trafficked by family members or neighbors. There are many opportunities for ordinary volunteers to be a big help to operations if they will just make themselves available.

The Lotus analogy compares the flower-of-life that emerges from the muddy waters to bloom into white, crisp purity. Lotus-Shadows is there for them to come from the shadows to bring them back to that light, to that lotus. Sarasota is the #3 hub for human trafficking in America. You would not want to involve yourself for fame, as you would be fighting against powerful elements. If there is any message to take away, it is: *Be Aware*.
