The CCW License certification course provides individuals with a variety of privileges and benefits - it allows approved people permission to carry a handgun outside their home in public - **LEGALLY!** They are allowed to carry a loaded handgun in a vehicle, and to carry a handgun in most public areas. The license certification process provides enhanced education and understanding of self-defense laws for the firearm owner, CCW license holders find it easier to purchase firearms, and earning the CCW license privilege gives the handgun owner more self-confidence and peace of mind.

**Range Qualification:** Handgun function test & qualification may be completed anytime that fits your schedule & mine, usually after Session 2 or anytime after you've registered for the CCW Course.

**The Initial CCW Course Consists of 2 Sessions:**

**Session 1: Lesson One:** Developing a Personal Protection Plan; **Lesson Two:** Self-Defense Firearms Basics; **Lesson Three:** Defensive Shooting Fundamentals; **Lesson Four:** The Legal Use of Force. **Lesson Five:** Violent Encounters and Their Aftermath;

**Session 2: Lesson Six:** Gear & Gadgets; **Lesson Seven:** Advanced Skills. **Lesson Eight:** County, State & Federal Laws & Policy. Review for Exam, Take Exam, Handgun Safety Check, Set a date for CCW Handgun Qualification, (Live Fire at the Range). **CCW Renewals Always Welcome** (Call for Details).

The **FT3 & La Puente Indoor Shooting Ranges**, are open 7-days a week, from 10 AM to 11 PM. During the week the range will be closed before we could arrive and on weekends, the Shooting Range is overcrowded, chaotic, and very difficult to conduct proper CCW handgun qualifications.

**IMPORTANT NOTICE: DON'T CHEAT YOURSELF!** Your CCW Training (Initial & Renewal) hours will follow you through your "CCW Career" and will end up as court record if you ever have to defend yourself. The exact length of our Initial CCW License course will depend on how long it takes to cover all of the topics required by the State of California. California CCW law demands a minimum of 8-hours and a maximum of 16-hours of certified CCW training. **Our EXCELLENT CCW TRAINING runs approximately 12 to 13-hours.**

**Beware Professional Opinion Ahead:** I am totally baffled. Why "firearms instructors" would create half a CCW class when there is a massive amount of subject matter to teach. Literally, lives, grievous bodily harm and fortunes are at stake in the realm of **Personal Self-Defense** and the **Use of Deadly Force**. With this in mind, I'm even more puzzled why students would cheat themselves by paying for a hollowed-out firearms training course that should include **E•V•E•R•Y•T•H•I•N•G** a person needs to know and understand about **Personal Self-Defense** and the **Use of Deadly Force**, but instead opt for an expensive course of training that's cut in half.

Concealed Carry License Holders need to understand: **Situational Awareness • Color Codes of Awareness • Conflict Avoidance (Fight or Flight) • Stand Your Ground • The Castle Doctrine • State & Federal Self-Defense Laws • Defensive Shooting • Legal Aspects • Reasonable Person Test • Use-of-Force • Use of Force Continuum • Legal Use of Deadly Force • Physiological Reactions Associated with Extreme Stress • When the Right to use Deadly Force Ends • What to do in the Immediate Aftermath • What Happens When the Police Arrive • What Should You Say to the Police • including a segment on What You Should Tell Your Attorney (because I'm certain your Divorce Attorney, Tax Attorney or Legal Zoom is not up to Speed on Defending YOUR Use of Deadly Force case)!**

So, if you intend to enroll in either an 8-hour CCW course online or a live CCW course that advertises an 8-hours flat and you're out the door course. Remember, that's half the maximum allotted time in California and it may come back to bite you. Even years later your CCW training will follow you.

No doubt, after you drop the hammer on some poor "**Dirt Bag**" the DA or prosecuting attorney will submit your 8-hour CCW "**LACK of TRAINING**" certificate as "**Exhibit A.**"

### CCW Course Pre-requisite:

CCW is not an entry level activity. CCW training is for experienced shooters who are at the "INTERMEDIATE LEVEL" of handgun knowledge & skills. At minimum, students should have taken a **Basic Firearms Fundamentals Course** or the **NRA Basic Pistol Shooting Course**. Other **Self-Defense and Defensive Shooting Courses** or equivalent are a plus. We teach Basic Firearms Fundamentals & Self-Defense and NRA Basic Pistol Shooting Courses often, contact us for details.
