Summer Bridge Course for rising 1st grade-9th grade : Students will be grouped by grade and will have a variety of academic lessons in effort to reinforce previously learned skills to better prepare them for the next grade. The classes are taught by certified teachers. Students will work on writing, reading, math, science, and will have breaks for fun activities, games, and arts/crafts. Students may come from public schools, private schools, or may be home school students. Students MAY enroll in multiple sessions and a more individualized and focused approach will be taken for the repeat student to work on during additional weeks. Special requests for certain skills are accepted and we will do our best to work more on those specific skills during the camp. Each class size will be limited to 15 students. Classroom teachers will have access to assistants for pull out and smaller group or one on one lessons with students.

9am-2pm Monday through Thursday for 2 weeks (40 hours).

Cost is \$400/student/session

Early drop off starting at 7:30am – 8:45am is available for an additional fee of \$80/ session or \$10/day

Late pickup between 2pm – 4pm is available for an additional fee of \$160/session or \$20/day (\$7.50/hour)

Late pickup between 4pm-6pm is available for an additional fee of \$320/session or \$40/day

Advanced registration for early and late drop off is required. We do have a minimum number of students required to offer early drop off and late pick up.

Registration is open now. A nonrefundable deposit of \$200 is required to hold a spot and the remainder of the summer tuition is due by April 15. Nonpayment or late payment MAY cause your student to lose their spot without refund. Students should bring their lunches and snacks. Drinks, snacks are available for purchase for \$1/each.

Liability/Medical Release

In consideration of my child being allowed to participate in the classes and/or activities, camps, and events at CHR or a separate location outsourced by CHR and activities provided by and or sponsored by Canton Homeschool Resources and all teachers, volunteers, and individuals associated with CHR, I assume all risk, including any risks associated with ay special medical needs or condition of my myself, family members, guests, of mine and my child, of our/my child’s participation in any such activities,

including travel incident thereto. I certify that I have insurance reasonably sufficient to cover my child against injury and loss of life caused to my child or caused by my child in connection with such participation and I agree that all expenses relating to or arising out of any such injuries or loss of life will be my sole financial responsibility and my child and I agree to release and hold harmless and indemnify, Canton Homeschool Resources, and all teachers, volunteers, and individuals associated with CHR from and against any and all liability for ANY harm, injury damage, claims, demands, actions, causes of actions or cost and expenses of ANY nature for which my child, my child's family, estate, heirs, administrators, representatives and assigns, arising out of or related to any loss, damage, or injury, including but not limited to suffering, pain, disability and severe injury (including death), that may be sustained by my child in conjunction with my child's participation in the classes and activities. I am solely responsible for anything that could happen and hold CHR and all affiliates harmless and not responsible. I understand and agree to these terms.

By enrolling at CHR or by attending any event or activity sponsored at or by the organization, including but not limited to classes, athletic events, dances, and field trips, you have released CHR from all liability and take responsibility for all injuries and accidents that may occur en route, on site, or at any of our events. You also agree to release CHR and any of its employees and contracted workers from any liability in relation to any school related activities/events or arranged transportation of children. You are also agreeing to several policies when you enrolled stated written and in verbal form and have released all agents from all liabilities in any form. CHR is not responsible for any student belongings. Should ANY dispute ever arise that should be taken to a legal level, this agreement ensures that mediation will be attempted avoiding an expensive jury trial and attorneys. By being a part of the CHR organization, you agree to this policy and waive your rights to pursue legal action outside of a mediation environment. This is beneficial for both parties as a third party, without the high costs of court, can make a legal decision.

In the event of an emergency, or perceived emergency, I understand that CHR will call 911 first and the parent second. I release CHR and its associates from all fees and repercussions that may occur from emergency services. I give CHR permission to treat and to have my child treated if medically deemed appropriate by CHR or emergency personnel. I hold all individuals attempting to assist my child harmless.

Students must be picked up on time. Those not picked up within 10 minutes of the agreed upon time will be placed in the aftercare program and the parent is responsible and is agreeing to pay these fees. They are not pro-rated and will be charged in whole for partial use of any amount.

Students are allowed to bring technology devices to CHR. As the parent, we encourage you to talk with your student about appropriate websites, cyber etiquette, and safety. While we try to monitor usage, students do have breaks when they like to bring out their devices. We cannot monitor every student closely enough to determine that every second is spent on an appropriate website. CHR, and its affiliates, are not to be held responsible for website activity outside what we instruct the students to use. We encourage you, as parents, to download apps to prevent your child from visiting adult sites if they wish to bring their devices to CHR. Teachers can and often will require students to NOT have their devices out during the day. It is at the discretion of the teacher and administration when devices can be used at CHR. Cyber bullying is immediate cause for dismissal at the sole discretion of CHR.
