Dear Dance Families,

Thank you for dancing with Debbi's Dance, Etc. this summer. We appreciate your incredible support and the opportunity to provide a valuable dance education and outlet for dancers. Thank you for continuing to follow the Safe Start protocols to keep everyone safe. We continue to follow the changing state guidelines and make adjustments as necessary.

End of Season Performances – Aug. 24-27. Last Day of Regular Classes – Aug. 21

The last day for summer classes is Friday, August 21. The following week (Aug. 24-27) will be dedicated to professionally streaming LIVE and recording class performances at Debbi's Dance, Etc. (thank you to dancers and parents for recording our large group routines this past week – those will also be streamed August 24-27). Recordings will be compiled to produce shows that will be available online. We are working out the performance schedule (please note: Friday classes will perform on another day that week) and will have that available soon. A \$25 per dancer recital fee (\$50 max family) has been charged to dancer accounts to support production costs. Included in this \$25 fee is the LIVE performance feed link to share with friends and family, access to a high-quality recording of all of the performances via a web link, and routine photos that you can download and print. Optional additional web link and commemorative DVDs will be \$25 each and order forms will be available online soon. Costume Pick Up – Sun, Aug. 9, 4-7:30 pm

Costumes that have been ordered will be handed out via curbside at Debbi's Dance, Etc. Sunday, August 9, from 4 – 7:30 pm. Please enter our parking lot from Linnea's side of the building and exit the other side of McKinney's to help with possible congestion. Please note: Dance accounts (including recital fees) need to be paid in full to receive costumes. Online payments prior to August 9th are encouraged, however, we will be able to take credit card and check payments via curbside on August 9th. Performing classes that started this summer do not need to attend the curbside pickup and will receive information from their teachers re: costume pieces to prepare for the Performance. Invoices -Summer invoices will be sent in a separate email. Please let us know if something doesn't look right. We have credited competition dancer accounts for lessons not occurring weekly. Please note: a \$25 per dancer (\$50 family max) recital fee has been added to performing dancer accounts. Please pay your balance for any outstanding lessons, including July & August tuition by August. 9th. Also note: invoices may not include all private lesson charges.
