5. Sign up this week for Required/Additional Supporting Classes: We want to make sure dancers are enrolled in and attend the proper technique classes to support the genres they're competing.
6. Vote to select the studio convention. Email us your pick by Friday, September 17<sup>th</sup>.
7. Link the Debbi's Dance, Etc. Google Calendar to your device (or manually add the 2021/22 Debbi's Dance, Etc calendar items to your personal calendars/devices).
8. Be sure we have your email address(es) so you can access your dance account remotely and receive competition dancer correspondence.

## **Routines to be Choreographed in 9-Week Sessions**

Each routine that dancers participate in will be charged as a 30-minute class charge starting when the corresponding choreography session begins. This charge will remain in place for the remainder of the dance season (through June). Most choreography sessions will likely run longer than 30 minutes and will be rehearsed during the competition dancer Monday 7 pm block after the choreography session has ended. The 30-minute charge for the remainder of the dance season is meant to be an average of all choreography and rehearsal sessions.

## Debbi's Dance, Etc. 2021/22 Competition Dancer Contract

**Commitments:** Our Competition Company will participate in "Mock" competition, 2-3 studio competitions, and a Dance Convention is encouraged. We ask that group members schedule other activities and vacations around these weekends so that our groups can perform as they are choreographed. It is difficult for the instructor and co-dancers to take class time to re-choreograph for even one dancer. Entry fees are due approximately six weeks before each event. Please pay attention to your studio calendar for entry fee deadlines. Solo and duo/trio dancers are welcome to participate in studio competitions, but participation is not required. Competition entries are limited at Convention. Please contact us if you're interested in entering a solo and/or duo/trio at convention. Dancers are also welcome to attend additional competitions and conventions, but please refer to your studio calendar and talk to your teacher before making these commitments. Competition dancers also typically do performances during the year. It's a unique year and the calendar will be updated if more opportunities arise. At this time, in addition to competitions and convention(s), please mark your calendar for Picture Day tentatively scheduled on Sunday, June 12th, hold the dates of June 16-18 for our Dance Spectacular Recital. We ask that you plan activities and vacations around these dates.

**Requirements:** Mini & Jr. Company dancers need to be enrolled in one additional weekly class, any genre. Tween, Teen & Sr. Company: One hour or more of ballet is required for all Jazz, Lyrical, Contemporary and Acro competition dancers. Ballet attendance will be monitored, and failure to meet the requirement can result in being held out of a performance or competition and in extreme cases, removal from the group. In addition, dancers must take a supporting class for each dance genre that they wish to compete, Jazz/Lyrical (we strongly encourage a Jazz AND a Lyrical technique class if your dancer competes in each genre), Contemporary, Tap or Acro (Hip Hop and/or Musical Theatre dancers need to take one additional class, any genre).

**Expectations:** Dancers should come to class each week with the proper attire, footwear and attitude. Dancers should get plenty of sleep and always bring water and plenty of healthy snacks to fuel themselves properly. "Fast Food," soda and energy drinks are extremely discouraged. Attendance is extremely important; it affects the whole group when even one student is absent. ***Session 1, 2 & 3 choreography session misses can not exceed two misses.*** Please limit your absences per class to no more than 4 for the entire dance season. In particular: dancers should not miss more than once in any given month, nor should they miss the week before a competition or performance. As with ballet, failure to meet these requirements can result in being held out of a performance or competition and in extreme cases, removal from the group. Above all, however, we want to keep all of our dancers safe. Dancers are asked to contact us if ill and please stay home and try to learn choreography before returning. Please consult the studio calendar before planning family trips or committing to other activities that conflict with our competition and show schedule. If you need to miss class due to an illness or emergency, please text the instructor. Solo and duo/trio dancers, it is your responsibility to text your instructor (and co-dancers if applicable) if you are unable to come to your scheduled time. 24- hour notice is appreciated for cancellations. We intend for students and parents of the Debbi's Dance, Etc. to strive to behave in a positive and constructive manner at all times and to utilize truth, fairness and integrity in the development of personal decisions and relationships both inside and out of the dance studio. Competition dancers are required to sign and abide by the dance studio code of conduct.

## Debbi's Dance, Etc. Code of Conduct

We intend for students and parents of the Debbi's Dance, Etc. to strive to behave in a positive and constructive manner at all times and to utilize truth, fairness and integrity in the development of personal decisions and relationships both inside and out of the dance studio.

Debbi's Dance, Etc. strives to offer the highest level of dance instruction in a positive, respectful and caring environment. In order to develop and ensure this environment, we ask all of our students and our parents/caregivers/families to abide by the following rules and code of conduct. These guidelines are intended to provide all dance parents and students guidance in daily settings.

### Dancer Code of Conduct

- Honesty and integrity are expected.
- Dancers must respect their fellow dancers, teachers, parents and dance families.
- Dancers must not distract or harass other dancers.
- Dancers must be polite and display good manners at all times.
- Dancers must refrain from cursing, using offensive racial or obscene speech, gestures or written materials.
- Dancers must refrain from physical, mental, emotional or cyber mistreatment of other dancers, staff, or instructors. This includes social media postings referencing directly or indirectly to a student, staff, studio brand, and/or affiliations to the studio.
- Dancers and company members are the face of Debbi's Dance, Etc. and should conduct themselves in a manner that reflects positively on the organization.
- When representing Debbi's Dance, Etc., dancers must continue to follow the Debbi's Dance, Etc. code of conduct as they are representatives of our organization.

### Parent/Guardian Code of Conduct

- Honesty and integrity are expected.
- Parents are encouraged to support their child's/children's involvement and help them enjoy the art of dance.
- Parents must demonstrate respect for faculty, staff, students and dance families at all times.
- Parents must not raise issues of disagreement publicly.
- Parents will not engage in inappropriate conduct towards instructors, staff, other dancers and families.
- Parents must discourage inappropriate conduct towards instructors, staff, other dancers and families.
- Parents will refrain from physical, mental, emotional or cyber- mistreatment of other dancers, staff, instructors or families. This includes social media postings referencing directly or indirectly to a student, staff, families, studio brand, and/or affiliations to the studio.
- Parents must remember that children participate in dance for their own enjoyment.
- Parents will teach their children respect for other students, teachers and adults and lead by example.
- Parents will encourage and guide their child to accept responsibility for his/her own performance and behavior.

On the occasion that failure to comply with the Code of Conduct occurs, Debbi's Dance, Etc. reserves the right, at its discretion, to dismiss or take disciplinary action on any students or parent/guardian/family member who breach the Debbi's Dance, Etc. code of conduct.
