## Debbi's Dance, Etc. 2025/26 Competition Dancer Contract & Billing Schedule

### Commitments:

- Competition Co. participates in Competition Preview, 2-3 studio competitions & a strongly encouraged convention.
- Refer to the studio calendar for dates & fee deadlines. Additional performances may be scheduled throughout the year. Full company participation is expected for competitions and events. Please schedule vacations and other activities around them or you may be charged re-staging fees.
- Solo and duo/trio dancers are welcome but not required to participate in studio competitions, and must attend Company Class & Required Technique class(es) for their level and genre.

### Requirements:

- **Attire:** Debbi's Dance team jackets and Team T-shirts are required at competitions and events. Dancers must sit with the team & support each other at award ceremonies.
- **Performing Group & Shimmer Company Dancers:** Must take one additional weekly class (any genre).
- **Spark: Company Class (Sundays 3:45-4:45 pm)**, plus the following based on which genre groups they're participating:
  - **Jazz, Lyrical, or Musical Theatre Group** → 1-hr Ballet class + Jazz or Lyrical class (your choice)
  - **Hip Hop Group** → Additional class (any style)
  - **Tap Group** → Tap technique class
  - **Acro Group** → 1-hr Ballet class + Acro technique class + Jazz or Lyrical class*Note: Ballet/Lyrical class counts as ballet or lyrical, not both.*
- **Synergy: Company Class (Sundays 3:45-4:45 pm)**, plus the following based on which genre groups they're participating:
  - **Jazz Group** → 1-hr Ballet class + Jazz class
  - **Contemporary Group** → 1-hr Ballet class + Contemporary class
  - **Lyrical or Musical Theatre Group** → 1-hr Ballet class + Jazz, Lyrical, or Contemporary class
  - **Hip Hop Group** → Additional class (any style)
  - **Tap Group** → Tap technique class
  - **Acro Group** → 1-hr Ballet class + Acro technique class + Jazz or Lyrical class

Important Note for Returning Dancers: 2025–26 Competition Company dancers wishing to participate in the 2026–27 season will be required to take a minimum of one class during the 2026 summer session.

### Billing, Choreography & Rehearsals:

- Spark & Synergy Competition Routines: \$27/month per group routine (Sept-June), covering choreography, staff, and competition costs. Rehearsals are typically Sunday afternoons or evenings, with some during the week/weekends. Times may be adjusted.
- Shimmer & Solo/Duo/Trio dancers not in Competition Group Routines: Normal class rates apply plus a \$48 participation fee.
- Multi-class discounts apply to technique classes but not competition rehearsals.
- Late payments may result in dismissal from the competition program.

**Expectations:** Dancers must attend classes weekly with the proper attire, footwear, and a positive attitude, stay hydrated and bring healthy snacks. Fast food, soda, and energy drinks are discouraged. **Attendance is crucial. Limit absences to no more than 4 for the entire season and avoid missing class within 2 weeks of a competition or performance.** For illness or emergencies, notify your instructor via BAND.
