### **Evacuation/Relocation and Walking Field Trip Permission**

Our class **may** take walking field trips and/or practice walking to emergency relocation/evacuation sites throughout the year. This permission form may be used in the event of an actual or practice drill of an emergency/disaster.

This **Relocation/Evacuation and Walking Field Trip Permission Form** provides a release stating that you as the parent/guardian authorize Red Oak Montessori School to take your child off the child care site for the purpose of relocation/evacuation and/or field trip.

A relocation drill may require walking your child to primary and alternative relocation sites. This permission covers your child's participation in emergency relocation/evacuation drills throughout the year. These drills involve leaving the child care facility site with child care staff.

All walking field trips will be in the vicinity of our school and may include, but are not limited to: small wooded area outside playground behind the school, through the neighborhood using side roads, across Sanborn Street to fields and woods.

You will be notified in advance when a relocation/evacuation drill and/or walking field trip will take place and where to pick up your child, if other than from Red Oak Montessori School.

All possible care and safety will be provided for your child and will take place under the supervision of the Lead teacher. An additional teacher will be present depending on the number of children present, per NHCCLU rules.

A notice will be posted in the lobby on the morning of the relocation/evacuation drill or walking field trip stating the destination, time of departure and time of return to the school.
