TERMS AND CONDITIONS

REGISTRATION:

- ❖ The concerned person (Proposed Bride/Groom) has to be registered and enrolled herself/himself as a member of Al-Falah Marriage Bureau [AFMB], Bangalore. The prescribed Registration Form available to be filled up and signed OR submit their detailed Bio-data.
- ❖ While furnishing essential details and personal information in the relevant columns, one has to furnish with fairness and honesty. All the details should be true, accurate, current, latest and complete in all respects.

REGISTRATION FEE:

- ❖ The below table shows the details of Registration Fee the members can select at the time of registration, which is non-refundable.

- ❖ The Validity of membership/Tenure of the service by AFMB shall be for the period specified while registration or till the date of marriage, whichever is earlier from the date of registration.

PHOTOGRAPHS:

- ❖ While submitting registration form, to get better search results, the members are expected to provide latest two photographs which should not be of more than 3 months old. One photo should be of full length and another one should be close up half.

SELECTION OF ALLIANCE:

- ❖ AFMB starts sending the matching profile once a member registers, and also share the profile with other members too on their whatsapp. The shortlisted/ selected profile along with photos will be sent to the respective families as preferred.
- ❖ The members are requested to exercise due care and caution while short-listing the profile and satisfy themselves before making a choice of profile. It will be whole responsibility of members to verify properly about the concerned match with respect to personal information such as age, height, complexion, educational qualifications, job status, monthly income, hobbies and habits etc.,
- ❖ Once the selection of alliance is done after verification by the member as per his/her /family members' choice, then AFMB's responsibility ceases. AFMB will not be held responsible for any kind of differences arising between Bride/Groom and respective families during making alliance or even after marriage. AFMB cannot guarantee or assume responsibility for any specific results from the use of its data/profile provided.

MARRIAGE CONSIDERATION FEE:

- ❖ Total amount will be Rs. 50,000/- in two instalments.
- ❖ After engagement the member should pay the 50% of marriage consideration fee (service charges) Rs. 25,000/- (Rs. Twenty Five Thousand only) as agreed upon at the time of registration.
- ❖ The remaining 50% Rs. 25,000/- should be paid at least one week of before marriage as mutually agreed and accepted.
- ❖ In case of any dispute arises before or after marriage between the respective Bride/Groom, AFMB will not be held responsible for refunding the amount towards registration fee/ marriage consideration fees paid by the respective members as on date.
