## What you need:

- Application SP-248 (07-1-2021)
- Your Driver's License showing your address in Northumberland County
- If new application:
  - Your original certificate showing completion of an IN PERSON Hunter Safety course or original IN PERSON Handgun Training Course, or your Military DD-214.
- If renewing:

If renewing, a copy of your concealed handgun permit.

- A self-addressed stamped envelope
- \$25.00 payable by Credit Card (Visa, Master Card or Discover), check, money order or cash Exact Change
  - \*\* Checks and money orders are to be made out to Northumberland County Circuit Court (NCCC)
    - o There will be a convenience fee if you use your credit card
- NO REFUNDS

### How to complete the form:

- NAME: Enter complete legal name. NO INITIALS
- ADDRESS: Write your P.O. Box and Physical address on the application.
  - o Attach a separate listing of all addresses within the last 5 year period.
  - o Email address must be written clearly

# After the Concealed Handgun Application has been signed:

- Leave the application with us and we will give it to the Sheriff's Office; they will perform your background check
- Once the Sheriff's Department has completed the background check, they will either approve or deny the application and return it to the Circuit Court Clerk's office
- An order will be prepared for the judge to sign
- Once the order has been signed, we will mail you your permit in the self-addressed envelope, or a copy of the order denying your application.
- This process may take up to 45 days from the date of application.
- Please sign your permit immediately upon receipt.
- As a courtesy, we will laminate your card. Just stop by our office at your convenience.

#### RENEWALS

Permits may be renewed six (6) months prior to the expiration date.

To renew you will need the following:

- Application SP-248 (07-1-2021)
- Your Driver's License showing your address in Northumberland County
- a copy of your concealed handgun permit.
- A self-addressed stamped envelope
- \$25.00 payable by Credit Card (Visa, Master Card or Discover), check, money order or cash Exact Change
  - \*\* Checks and money orders are to be made out to Northumberland County Circuit Court (NCCC)
    - o There will be a convenience fee if you use your credit card
- This process may take up to 45 days from the date of application.
- Please sign your permit immediately upon receipt
- As a courtesy, we will laminate your card. Just stop by our office at your convenience.
