- 1. Meeting Called to Order 6:35pm
- 2. Guest Speakers Code Enforcement (Dept. 813-274-5545) Carlos Rios and Ryan Shepherd (Ryan 813-255-4037)
 - Organization, Policy, and Procedures
 - i. 33 inspectors work Monday through Friday, 8:00 to 5:00 p.m.Occasionally work on the weekends.
 - ii. Code enforcement operates under Chapter 19, Chapter 20.5 and Chapter27 of the code.
 - iii. Inspectors use an inspection sheet to assess the whole property for violations, not just the original violation reported to them.
 - iv. An inspector is not allowed to look over someone's private property fence. However, if invited an inspector can stand in the property next door on a higher level, such as a deck, to look over the fence to visually inspect for violations.

- v. It is important to know when someone reports a code violation online they must submit their name and address and phone number. People who wish to remain anonymous can use another person's name to report for them a code violation. It is common for neighborhood associations board members to report for residents.
- vi. Remember people who are in violation can look up to see who is reporting them because it is public record.
- vii. There are two types of code offenders: chronic and repeat.

Enforcement and Violations

- Some common examples of what code enforcement violations they address: minimum standards of construction, overgrown grass and plants, abandoned vehicles, and removing trees without a city permit.
- ii. For abandoned cars if there is a good tag and good tires on the car it is not a violation. If a violation is found on a car the owner has 21 days to bring the car up to code.
- iii. Using the civil citation process is the quickest turnaround time to enforce code violations.
- iv. A person could be issued an instant \$75 citation, if they do not pay the first \$75 it escalates to \$100. If this is not paid they can be brought to court, and they can be placed on probation if they are found guilty.

Questions from the audience:

- i. Is code enforcement or the housing authority responsible for addressing mold in a home?
 - In the state of Florida there are no state regulations regarding mold.
- ii. Is code enforcement responsible for issuing citations related to noise?
 - No, it is the police's responsibility to enforce the city noise ordinance.

- iii. Can businesses have portable restrooms on the sidewalk outside their business?
 - 1. Typically no, unless they have an event permit.
- iv. Who is responsible for paying when trees are illegally removed?
 - Homeowners who cut down trees without a permit are responsible for paying the city fine. The tree cutting company is not fined.
- v. Outside seating and cueing for clubs in Ybor?
 - In Ybor City sidewalk permits are required for roped off areas to form a line to enter an establishment, have a podium outside, and have seating outside.
- vi. AirBnB's used as party houses?
 - Ryan and Carlos reported investigating an Airbnb being used as a club. They are still investigating the group who organizes club events at local Airbnb's.
- vii. Is plywood required for windows?
 - 1. Yes. The inspector has the ability to use a city contractor to secure
