RYC Mud Park Off-Road Vehicle Code of Ethics and Conduct Agreement

At RYC Mud Park, we are committed to providing a **safe, family-friendly environment** for all guests. As an **off-road vehicle owner**, you are required to adhere to the following **Code of Ethics and Conduct**. By signing this agreement, you acknowledge and agree to these terms as a condition of participating in park activities.

1. Zero Tolerance Policy

- Any reckless driving, unsafe behavior, or actions that jeopardize the safety of others will result in **immediate removal** from the park without a refund.
- Disrespectful, aggressive, or disruptive behavior toward park guests, staff, or property will not be tolerated.

2. Family-Friendly Environment

- The park is a space for families to enjoy. **Aggressive**, **inappropriate**, **or vulgar behavior** is **prohibited**.
- No nudity, lewd acts, or offensive gestures of any kind will be allowed.

3. Respect for All Park Guests

- All off-road vehicle drivers must show respect toward other riders and guests, including ATVs, SXSs, Jeeps, and smaller tagged and insured vehicles (e.g., Toyota Tacomas, Bronco II, Ford Rangers, Suzuki Samurai).
- Sharing the trails safely and courteously is mandatory. Intimidating or harassing other park visitors is strictly prohibited.
- Absolutely no burnouts, drag racing, donuts, or other unsafe stunts in any area of the park.
- No speeding on the main road, in any low-speed zones, or in the vendor area.
- No off-road vehicle is allowed to drive fast or recklessly in the vendor area. Any violation of this rule will result in immediate removal from the park without a refund.
- You must operate your vehicle with control and show respect for other guests, their vehicles, and the environment.

4. No Lane Behavior

"Lane behavior" includes, but is not limited to:

- Fights, confrontations, or instigating altercations of any kind.
- Nudity, inappropriate public displays, or any behavior that is not family-friendly.
- Lining up vehicles on one or both sides of an area to create a "lane" for others to drive through.



Lane behavior is strictly prohibited. Violations will result in immediate ejection from the park and **permanent suspension.**

IMPORTANT NOTICE:

Our park is now fully **family-friendly**. Be forewarned that any act of **nudity or lewd and lascivious behavior** can be prosecuted as a **sex offense under Florida law**.

⚠ If minors are present, any inappropriate behavior may result in additional legal consequences, including charges related to exposing minors to indecent or unlawful conduct. Law enforcement will be contacted immediately, and violators will be permanently banned from the park. You have been warned.

5. Bonfire & Guardrail Area Restrictions

- No full-size trucks or oversized off-road vehicles are allowed inside the bonfire area or anywhere inside the guardrail-enclosed area of Bikini Beach or the riding area.
- All larger trucks and off-road vehicles must park outside the guardrail.
- Only smaller vehicles, ATVs, SXSs, and golf carts are permitted to drive up to the bonfire area.

6. Trail Use and Driving Rules

- Drive **only** on designated trails or areas as directed by park staff.
- Always maintain a **safe distance** from other vehicles and pedestrians.
- Speed limits and any posted signage **must be obeyed** at all times.
- · Always watch out for other off-road vehicles.

7. Respect the Environment

- Keep all trails and areas clean. Dispose of trash properly.
- Avoid damaging park property, trees, or wildlife habitats.

8. Alcohol and Substances

• No consumption of alcohol or use of illegal substances while operating a vehicle.

9. Participation and Waiver

- **Participation is at your own risk.** All drivers must sign the park's liability waiver before entering.
- You acknowledge and agree to follow all park staff instructions and rules.

If any **interaction or incident** involving your dog is reported or observed in a negative way, you will be **asked to take your dog home or make immediate arrangements for their pickup**.
