

## RULES AND REGULATIONS;

1. NAME OF THE ASSOCIATION : *Sri Vidya Nikhetan educational society,*

2. LOCATION : *15/1010-5-1 Teachers colony, Tadipatri (TOWN),*

*Anantapur (D.T.), Andhra Pradesh (A.P.)*

3. MEMBERSHIP: The person who wants to enroll as member in the Society he has to be paid Rs. *100/-* towards membership and also to be paid Rs. *50/-* monthly subscription. The person who fails to renew his membership before the end of three succeeding months, automatically ceases to be a member. No member shall be entitled to vote whose subscription shall have been in arrear for a period not exceeding three months.

### 4. GENERAL BODY AND ITS FUNCTIONS ;

- i. To elect executive body or managing committee;
- ii. To pass budget for ensuing year and approve the expenditure statement for the previous year;
- iii. To approve the report of the activities of the Society;
- iv. To appoint an Auditor;

5. EXECUTIVE BODY : The executive body shall consists of ( *7* ) *Seven* members of which the President, Secretary and Treasurer elected by the General Body to have over all supervision over the day today administration;

### 6. MEETINGS:

- i. The general body shall meet once in a year in the month of *March* and the elections for the general body shall conducted ever three years to elect office bearers;
- ii. Extra- ordinary meetings of the general body may be convened at an time when called for by the executive body within 10 days notice to all members;
- iii. The executive body will meet once in a month or earlier if there is need for it.

7. QUORUM : The quorum for both general body and executive body meeting shall be  $3/5$  (three fifths) present and voting.

### 8. DUTIES OF OFFICE BEARERS:

i. **PRESIDENT:** The President shall preside over all the meetings of the body, governing body and sub-committee. He shall have the right to call for emergency meeting for transaction of the urgent matters if an. He can sanction expenditure to the extent of Rs. *500/-* at a time in an ear subject to subsequent sanction in Governing Body.

ii. **VICE PRESIDENT:** In the absence of the President he shall perform the functions of the President.

iii. **SECRETAR:** The Secretary shall be the Chief Executive shall be incharge of the management of the office of the association. He shall conduct meetings of the general body. He shall prepare the agenda for the meetings in consultation with the President. He shall maintain the minutes of the proceedings of all the meetings. He shall carryout the resolutions passed by the General Body. He has to place before the Governing Body every year the revised budget of the academic year. He shall maintain all the Registers and Accounts of the association. He can sanction expenditure to the extent of Rs. *2500/-* at a time in a year subject to the subsequent sanction of the Governing Body. He shall look after day today administration of the association.

iv. **JOINT SECRETARY:** He shall assist the Secretary.

v. **TREASURER:** The Treasurer shall be the Chief Custodian of funds of the society. He shall be the incharge of all cash and finance of the society. He shall maintain such accounts as they are prescribed by the governing body.

8. a. **SUIT:** The association may sue or sued in the name of the Society.

8. b. **'BANK ACCOUNT:** The funds of the Society shall be operated b the \_\_\_\_\_ and \_\_\_\_\_ jointly in any bank or in post office.

9. **FUNDS:** The funds of the Society shall be deposited with an approved Nationalized/Rural Banks or in a Post office. The funds of the Society shall be spent only for the attainment of the objects of the Society and no portion there of shall be paid or transferred directly or indirectly to any of its members through any means.

10. **AMENDMENT:** No amendment/alteration unless it is voted 3/5th of the members present meeting and confirmed by the votes 3/5th of the members present at a second special meeting convened by the Governing Body at an interval of one month after the meeting.

11. **DISSOLUTION OR WINDING UP:** Any number not less than 3/5th of the members of the society may determined that it shall be dissolved. If upon the dissolution of the society there shall remain after remain after the satisfaction of all its debts and liabilities any proper what so ever, the same shall be transferred to some other society having similarity aims and objects but shall not be paid or distributed among the members of the society.
