### Payment Terms

All advertising placements are secured on a 12-month agreement.  
Full annual payment is required prior to banner production and installation.  
Banner placement is reserved only once payment has been received.  
Payment plans may be considered at the discretion of Cedar Ridge Estates.

### Availability & Priority

The majority of advertising placements are allocated to long-term advertisers to maintain consistency and visibility across the facility.  
Consideration is also given to event sponsors based on sponsorship level and overall contribution.
