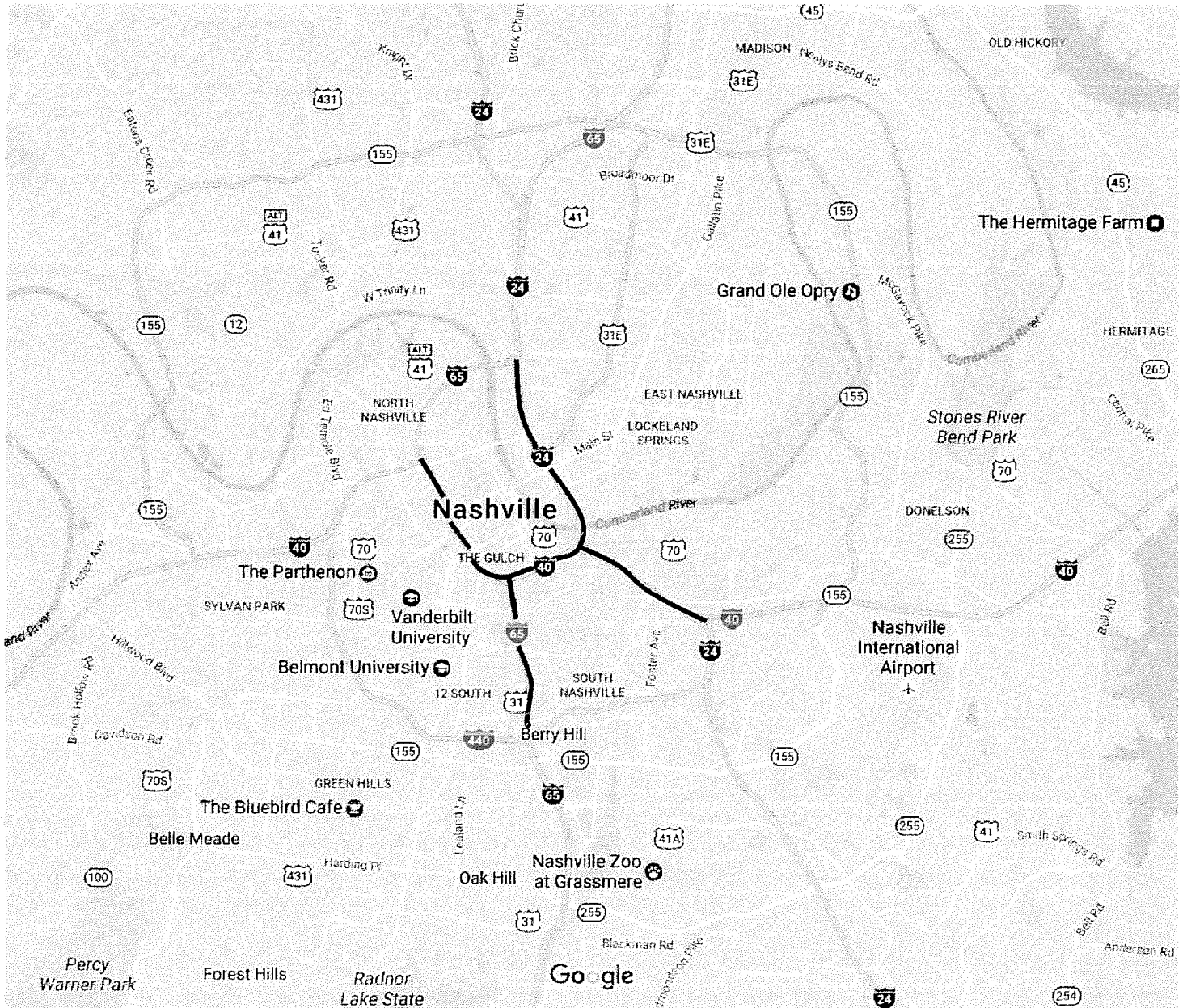

- All permit fees are non-refundable.
- Permittee is responsible for any damage to roadways, bridges, or to the travelling public 55-7-106
- Movement to be marked with signs and flagged in accordance with rules and regulations adopted by this department
- An original permit shall be in possession of the driver of the permitted vehicle at all times during the authorized move; provided, however, that an electronic permit is acceptable so long as the bar code is scannable. The permit shall be presented to TDOT, the Tennessee Department of Safety and Homeland Security, or other law enforcement whenever requested.
- All permit holders requiring travel off the state highway system are responsible for coordination with local government having jurisdiction of such other roads.
- The permittee is responsible for the accuracy of all information contained within the permit.
- Permits may be subject to restrictions on time of movement during inclement weather or weather-related emergencies when conditions prevail that could make movements unsafe.
- All loads shall be secured as prescribed in 49 CFR 392.9(A) 1), 393.100 through 393.142 .
- All over width movements shall observe traffic conditions and shall, when traffic begins to accumulate behind the movement, pull off the road and allow traffic to pass. Failure to observe this highway courtesy shall allow for the state enforcement officers to declare the permit void.
- In accepting this permit, the permittee acknowledges that the permittor is not a guarantor of the safe passage of vehicles. Accordingly, it is the positive duty of the permittee to measure all clearances of highway structures, both laterally and vertically, prior to the passage of the vehicle through their location.
- This permit is required to be issued by Tennessee Law. The permittee is hereby advised that information supplied herein is not necessarily accurate and is advisory only. Therefore, it is to be used at the sole risk of the permittee

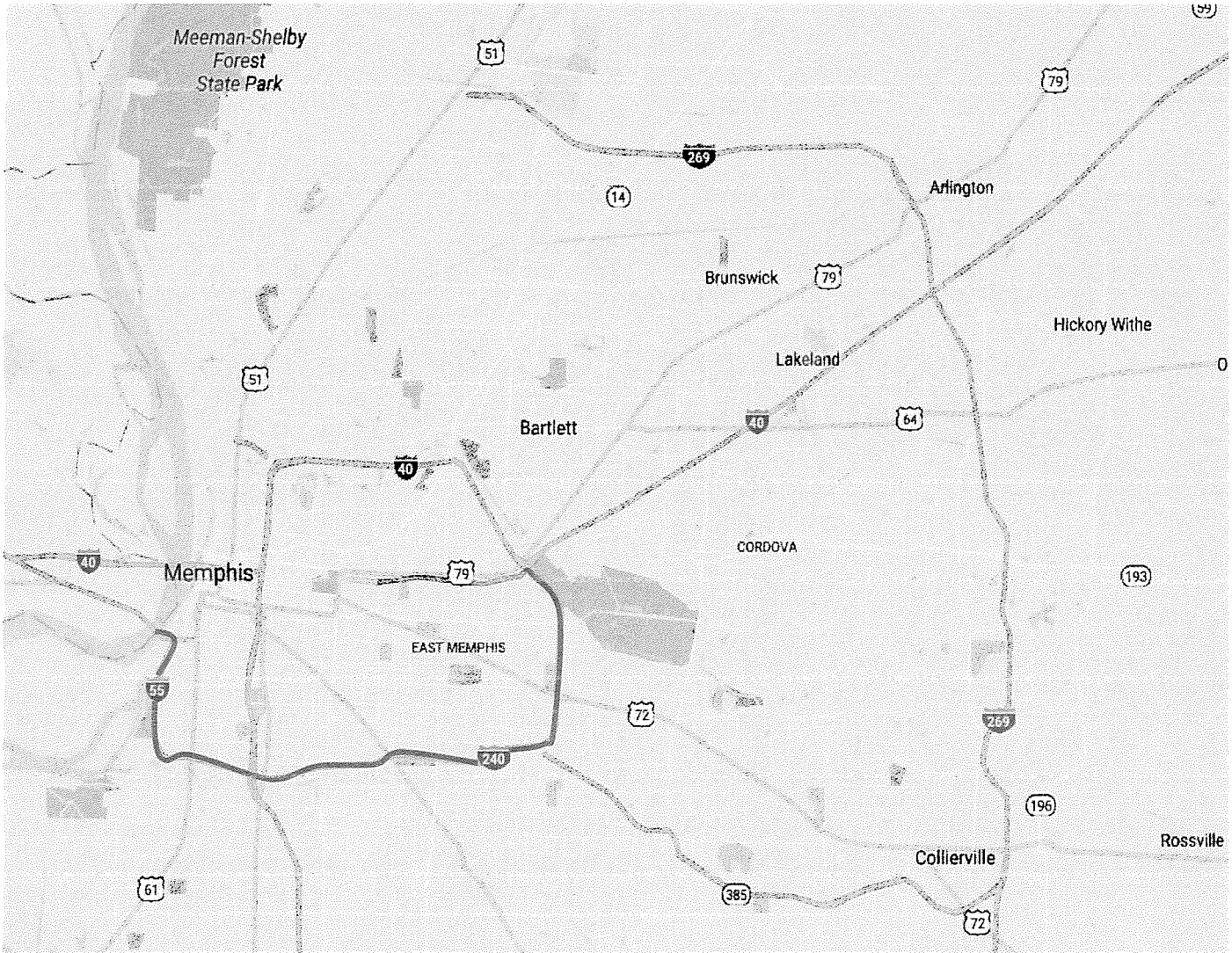
