

Silver Eagle Stable By-Laws

1. Established "Barn Hours" are Monday through Sunday from 8:00 am to 9:00 pm.
2. Monthly Board is due by the 5th day of every month. Management reserves the right to impose appropriate late fees, levy liens, seek title, and dispose of abandoned property when necessary.
3. Boarders will provide accurate address & phone numbers so that they may be reached in an emergency.
4. If you are delinquent on your board for three (3) months, your horse & any remaining property will become property of Silver Eagle Stable.
5. All accounts, including Board, Farrier, and Vet. Services etc., must be "Paid in Full" prior to final removal of your horse.
6. All horses stabled at Silver Eagle Stable will have all mandated shots, paid for by the Boarder, twice a year (Spring & Fall) to ensure a healthy environment. Proof of compliance will be required by all Boarders.
7. All guests and Boarders must sign a "Hold Harmless" agreement, regardless whether they ride or not.
8. No outside instructors are permitted to instruct on Silver Eagle property without permission of management. A \$15.00 ring fee is mandatory for outside instructors.
9. Any Boarder that "leases-out" their horse must inform management. The lessee must prove to Silver Eagle Management that they are able to safely ride and handle the horse.
10. Silver Eagle Stable horses are for lessons and other organized barn activities only and are not for loan.
11. Anyone that needs to borrow a Silver Eagle saddle, bridle, or any other tack must get Management's permission first and return it to its place when finished being used and cleaned if needed.
12. No minor (under 18) may trail ride alone. Adults may do so but it is highly recommended cell phones go with the rider and/or someone on premises is told.
13. Only one rider on a horse. No double riding.
14. All grooming will be done on the cross ties in the main hallway, or at the wash rack. Do not leave your tethered horse unattended. Be mindful of horses or people waiting or needing to get by you.
15. You may not use "treats" to field catch your horse.
16. No children under 15 may be left at Silver Eagle Stable unattended without prior approval by Management. All children must be accompanied by a parent or guardian unless approved by Management.
17. Clean up after your horse. Properly dispose of clippings, droppings, etc.
18. Clean up after yourself. Dispose of all trash & unwanted items in the trash receptacles provided.
19. If you damage or break something, you are expected to promptly advise Management and repair or replace it.
20. A fee will be assessed by Silver Eagle when Silver Eagle Stable trailers any horse.
21. Tack rooms are provided for each Boarder to store their equipment. Any items left outside the stall must be neatly organized & not obstruct the hallway. Any unmarked items left laying around grounds will be held for 1 week and then disposed of as Stable deems necessary.
22. All medications, fly sprays, ointments etc. will be supplied by the Boarder. Please mark & store them properly. Silver Eagle Stable supplies are for Silver Eagle horses only.
23. No one will operate any of Silver Eagles vehicles/machinery without Management's permission.
24. Operation of any vehicles/machinery will be conducted in a safe manner.
25. No running, yelling, or any activity that may spook the horses and cause injury.
26. Borders and visitors must report all injuries immediately to management.
27. By signing this agreement, Boarders agree to allow Silver Eagle Stables to act in "Good Faith" in an emergency on the horse's behalf, in the event that the Boarder is unable to be contacted. Any costs incurred are the responsibility of the Boarder.
28. Management reserves the right to add, delete, or amend regulations with notice to the Boarder.
29. Anyone not adhering to the above rules are subject to expulsion from Silver Eagle Stables.
