Puppies and kittens can be spayed/neutered as young as 8 weeks old. Don't delay.

Advantages

- Spayed females won't experience the physical and behavioral issues associated with going into heat.
- Neutered males are generally better behaved and less likely to roam away from home.
- The risk of certain cancers is lowered and, in some cases, eliminated.
- Over 32,000 kittens can potentially be born from one unspayed female cat and her offspring in seven years. Spaying significantly reduces pet overpopulation.



4 Steps to Better Giving

How to Put Your RMD and Your IRA to Work for Your Favorite Charity By: K. Brad Tedrick, CFA, CFP, President, Vantedge Wealth

We meet people every day that want to donate to charity for all the right reasons but finding ways to effectively give can feel both daunting and overwhelming. It's time to take a closer look at your IRA, its required minimum distributions (RMDs), and how they can go to work for you. If you have an RMD and you don't need these funds, you can donate it to charity as a qualified-charitable distribution (QCD). This is a great way to support charities and causes that you care about. A QCD of up to \$100,000 directly from an IRA to a charity will not be taxed.

So how can you make this happen? Here are some ideas:

Calculate and plan: Find out what your minimum RMD is for this year. Next, decide which account to make withdrawals from and how much of that withdrawal you plan to give.

Arrange: Select a qualified 501(c) 3 organization to support.

Give: Gifts of up to \$100,000 from an IRA or an employer-sponsored retirement account can be given tax-free. Donations made by Dec. 31 will qualify for this year's tax return. When you file, make sure to include your donations on the right tax documents, (Form 10r 99-R, Form 1040, or Form 8606).

Think Ahead: Start thinking ahead to next year and how you will distribute next year's withdrawal. There is always the possibility that tax laws could change so it's important to talk to a financial advisor and stay ahead of the curve so you can continue to give with both your heart and your mind.
