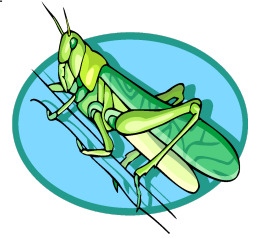

## 2022 Crook County Weed and Pest Program Policy Noxious Weeds (Private Landowners)

**Cost Share designated: Crook County Weed and Pest 60% Landowner 40%.  
(Up to \$2,000.00 Cost Shared by the District) If a Landowner needs more funding, they  
must petition the Board for approval. There will be no cost share on labor**

### **Cost Share Requirements:**

All tax paying land owners of Crook County are entitled to have Cost Share for chemicals applied to designated Weed and Pest in Crook County.

### **Landowner:**

**\*Landowner\*** means any owner or lessee of State, municipal or private land, and including an owner of any easement, right-of-way or estate in the land. Federal Landowners mean the federal agency having jurisdiction over any lands affected by the act ( Wyoming Weed and Pest Control Act of 1973) Title 11, Chapter Five, (a)(xx).

**Supervisor may inspect any land before, during, or after application.**

Registered, approved chemicals shall be used on the Wyoming designated noxious weed or pest and shall be applied according to the label.

**Chemicals must be applied in the fiscal year they are purchased. Fiscal year is July 1 - June 30.**

There shall be **no charging chemical to another party** without prior approval on file at the Weed and pest Office.

There will be **no purchases of restricted use chemicals** without a valid certified private or commercial applicators license. Purchasing restricted use chemicals without a license may be allowed with prior approval of a chemical authorization form.

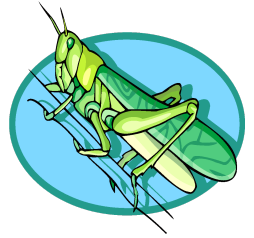
Pesticide may be purchased at any authorized dealers other than Crook County Weed and Pest. To receive cost share from the District, one must:

- a. Have paid Invoice from authorized dealers.
- b. Must Provide Proof of payment.
- c. Sales receipts shall be submitted within 60 days of purchase to the District Office.
- d. The District will pay the lesser of; District or Dealer Price.

Purchases shall be paid at time of purchase or 30 days from billing date, interest free. After 30 days, interest will be charged 1.5% per month until paid. After 90 days the cost share shall be relinquished, and the landowners shall be 100% responsible for purchase price

This Weed and pest program shall be in effect under the following provisions:

- a. As long as the County Mill Levy & the Wyoming Department of Agriculture funds are available.
- b. It also may become necessary to put each cooperator on a prorator on a prorated basis which will be determined by the District each year.
