TERM OF MEMBERSHIP:

- Early cancellations are subject to a \$100 exit fee, upon the completion of a minimum of 6 full months of membership, and only under the following circumstances: 1. Move out of the area [more than 30 miles]. 2. Documented Medical Condition.
- Upgrade to current membership is available at anytime.

BILLING AGREEMENT:

This application is for a membership agreement with Chris and Ted Golf Operating Company LLC. Member agrees to pay the first month's dues (pro-rated) in advance. **This membership is for a one year contract** and will automatically renew at the end of twelve months unless a letter of resignation is submitted. The management of the Operating Company reserves the right to change the dues structure at any time. Should this result in additional amounts, the renewal rates will be based on the rate that is in effect at the time of renewal.

MEMBERSHIP FREEZE: 15-Day notice is required to freeze membership. Members may freeze the membership for non-medical reasons in increments of one (1) month, for a total of three (3) months per twelve (12) month term. The freeze months are in addition to the Member's established payment obligation for the first 12 month term. All freeze requests are subject to approval.

A credit card or ACH authorization is required as security for payment of your monthly statement. All billing and credit card information will be kept in the strictest confidence. **CREDIT/DEBIT CARD PAYMENTS will incur a 5% convenience fee.**

Billing for club charges will be provided to you on the 1st of each month. Applicable sales taxes will be applied to all dues payments. If payment is not received by the fifteenth (15th) of each month, the club will automatically bill your credit card or bank account. A late fee of one and one half (1.5%) of the balance due will be applied if payment is not made by the fifteenth (15th) and/or the credit card company declines authorization on account.
