# Rules and Regulations

Show respect for the driver and follow the driver's instructions.

Client is responsible for any damage to the bus or its equipment, accidentally or otherwise.

Violence will not be tolerated.

- ❖ We accept money orders, cash and with proper ID credit cards (MasterCard and Visa)
- ❖ Cancellation Policy: If you cancel booking 7 days prior to your event, you will be responsible for 50% of the rate if we are unable to re-book your date. If cancelled later than 7 days prior to your event, you will be responsible for 100% of the rate charged if we are unable to re-book your date.
- ❖ Payment of full lease is to be paid to the driver upon arrival unless full payment is made in advance. A \$35.00 fee will be charged for bad credit card processing.
- ❖ Starting and ending times must be enforced. (Subject to driver and lounge availability.)
- ❖ **"Citysmoke Mobile Cigar Lounge"** is not responsible for any lost or stolen items during the ride or items left after the ride has ended.
- ❖ The **"Citysmoke Mobile Cigar Lounge"** driver and/or employee reserves the right to eject any individuals, who they deem to be destructive, intoxicated, to pose a safety threat to themselves or others, or deemed to be using an illegal substance.
- ❖ **"Citysmoke Mobile Cigar Lounge"** is not responsible to underage consumption of alcoholic beverages at any time before, during, or after the ride. The driver has the right to inspect ID's and containers of passengers who appear underage.
- ❖ For any actions such as fighting, violence, damage to equipment and/or bus, harassment to the driver, staff, or anyone else in or around the **"Citysmoke Mobile Cigar Lounge"**, the driver reserves the right to terminate the trip. The Client will be responsible to find other transportation and forfeits full fare as a result.
- ❖ If a passenger should vomit on the bus, there will be a charge of \$200.00 payable to the driver or charged to the client's credit card. The driver will pull over when safe to do so.
- ❖ By signing up for and participating in the ride, the individual agrees that **"Citysmoke Mobile Cigar Lounge"** and it's employees are not responsible to any claims for injuries, loss, damage, death, liability, criminal and civil litigation for the participating individual arising out of or relating to the ride.
- ❖ By signing the contract, the above client agrees to assume full responsibility for any damages to the interior or exterior of the bus that is caused by any individual riding in the bus. The client is liable for the cost to repair and such damage as well as any cost for loss of **"Citysmoke Mobile Cigar Lounge"** service due to such damage.
- ❖ **"Citysmoke Mobile Cigar Lounge"** is not responsible for injuries or accidents in and around the bus. Alcohol impairs motor skills, balance and judgment. Clients are asked to remain seated while the bus is in motion. Move about at your own risk. Please use caution on steps.
- ❖ **"Citysmoke Mobile Cigar Lounge"** is NOT LIABLE in cases of unexpected vehicle breakdowns, accidents, severe weather or anything that may delay the timely arrival or cause cancellation of the trip. In the event of a cancellation due to mechanical problems, the trip may reschedule for another date. Client will be notified as soon as possible to let them know of unexpected problems that may postpone trip times.
