1. What is Bahamas Lotus Child Care Assistance Program?

Any service that requires looking after or providing of the child.

2. Who can apply for the Child Care Assistance Program?

Any principal applicant (i.e., adult/guardian) over the age of 18 that as a child and/or dependent between the ages of 0 - 17 years old in their care.

3. How to apply for the Child Care Assistance Program?

Link of application form.

4. Who can be counted as household members?

Any person that dwells within the same household for the last six months.



Frequently Asked Questions

1. What age does Bahamas Lotus (BL) consider a dependent?

Any child 13 and under.

2. What age does Bahamas Lotus (BL) consider an adolescent-dependent child?

Any person between the age of 14 – 17.

3. What age does Bahamas Lotus (BL) consider an adult?

Any person between the age of 18 – 59.

4. What age does Bahamas Lotus (BL) consider the elderly?

Any person over the age of 60.

5. What age does Bahamas Lotus (BL) consider a disabled dependent?

Any person under the age of 21.

6. What age does Bahamas Lotus (BL) consider a disabled adult?

Any person over the age of 22.



Frequently Asked Questions

1. What is considered income when determining eligibility?

Income is anything that is generated by the following: wages from employment and/or self-employment, retirement, pension, alimony, royalties, rental, social services benefits and child support.

2. Can someone assist me with completing the application?

3. How can I submit my documents?

4. What does Bahamas Lotus (BL) do with the information collected from applicants?

5. Why does Bahamas Lotus (BL) require financial documents from applicants?

BL requires financial documents so that we can better serve you when determining your eligibility and to render additional assistance if required.



Frequently Asked Questions

What documents do I need to provide with my application (principal applicant)?

1. Verification of birth: Passport/Birth Certificate and NIB.
2. Proof of enrollment (daycare – 12th grade) i.e., last report card.
3. Current proof of earned income and/or unearned income i.e., child support, government assistance or nonprofit/ private assistance.
4. If you are receiving assistance from National Health Authority (NHA) copy of card.
