## REESOR FARM KENNELS BOARDING CHECKLIST



Proof of up-to-date vaccinations including: Rabies, Bordetella, & Distemper/ Parvo - must be up to date within the last year & given at least two weeks prior to the stay (you can upload with your online form or email records to ReesorFarms@gmail.com)



Bring any medications, treatments, and supplements for your pet. There is a \$1 per injection/application fee. All oral medications are at no additional cost. Per state regulation, all medications MUST be in their original container with dosing instructions from the prescribing veterinarian.



Bedding is provided, but we always encourage you to bring bedding or a fabric item from home so your pet can be comforted by a familiar scent.



Bowls are provided. Please keep yours at home. Exceptions are slow-feed or elevated pet bowls due to medical concerns.



Feel free to bring some of your pet's toys for them to have during their stay. However, please DO NOT bring rawhides, pig ears, or bully sticks. There is always a chance for choking or intestinal blockage when a pet is left alone with any toy, so please use your own discretion and knowledge of your pets behaviors when bringing these items.



It is always recommended to bring your pets current food to avoid digestive upset. Food must be portioned with exact measurements for each meal. We want to make sure your pet is fed exactly the right amount, and that they have enough food to last their stay. Open bags of food and large containers will not be accepted. Should you choose not to bring your pet's food, we do offer an in house food for \$3 per meal. We feed 4Health sensitive stomach.



We welcome intact pets to stay with us. However, intact pets will not be allowed to interact with other animals in any way during their stay (including animals from the same household). If a female is in heat, or comes in to heat during her stay, there will be an additional cleaning fee applied to the total bill.

# Waiver

Reesor Farm Kennels agrees to provide services stated in this agreement in a reliable and trustworthy manner. In consideration of these services and as an express condition thereof, the client expressly waives any and all claims against Reesor Farm Kennels.

### 1) Health & Safety

- a) The client understands that all pets must be on file with a veterinarian and must be current with all vaccinations as followed: Rabies, Distemper Parvo, and Intranasal Bordetella (at least 2 weeks prior to services).
- b) The client understands that all pets must be treated with a monthly flea, heartworm, and intestinal parasite preventative. If fleas are found on a pet, a flea treatment (Capstar and/or flea bath) will be given at owner's expense of \$25.00+.

Pets infected with Feline Aids, FIP, ringworm or any other contagious disease cannot board with us.

- c) The client understands that pets may interact with other animals, employees, and visitors. The client must express any known aggressions that the pet has with other animals or people and the pet must be free of any communicable diseases. The pet is being admitted based on client's representation and admission may be revoked at any time for false representation.
- d) Reesor Farm Kennels is an active farm environment. Although pets will always be monitored when outside, there is still a chance they could encounter wild or other domestic animals, ingest foreign bodies such as rocks or sticks, and will generally be exposed to a farm environment.
- e) Dogs may be let out into an area with 5' chain link fence. Client must notify Reesor Farm Kennels if this may be an issue for your dog.
- f) Client is solely responsible for any harm caused by their pet to any employees, other pets/owners, or property. Client agrees to reimburse Reesor Farm Kennels for all costs (including, but not limited to: medical care and lost wages) associated with exposure to pet(s).
- g) Reesor Farm Kennels reserves the right to take pet(s) to the vet if necessary. Client will be contacted first to discuss next steps. If the client is unavailable, Reesor Farm Kennels will contact the client's vet on file. If the vet on file is unavailable, Reesor Farm Kennels will contact Lakeside Animal Health. Client is responsible for all charges including, but not limited to, vet fees and transportation fees.

## 2) Food/Feeding

- a) Food from home must be portioned by into Ziploc baggies or similar small containers. Large containers or bags of food cannot be accepted. This ensures the pet has enough food for their stay, and that there is no chance for miscommunication on amount to be fed.
- b) Reesor Farm Kennels is not responsible for damage by pets to items such as bedding or toys from home. Please do NOT bring bowls from home. The only exception will be slow feed or elevated bowls. It is recommended that the client provide the pet's own food as a change in diet can cause upset stomachs. In house food charge is \$3/meal.

#### 3) Pet Updates

a) Reesor Farm Kennels will post pictures/videos of pets periodically to our Facebook page (with the exception of Sundays). Reesor Farm Kennels cannot be held responsible to respond to individual requests for updates. If there is an emergency or issue that needs individual attention, an employee of Reesor Farm Kennels will reach out to owners on a case by case basis.

#### 4) Enrichment Activities & Add-on services

- a) Client must notify Reesor Farm Kennels of any known food allergies the pet may have.
- b) Reesor Farm Kennels may from time to time include pet friendly treats with ingredients known and verified safe for dog/pet consumption.
- c) For "Sniffari Walks", client must provide an appropriate harness. Reesor Farm Kennels reserves the right to terminate or deny this service at any time due to pet's behavior.
- d) For "Group Play", dogs must pass a behavioral evaluation. This service will only be offered if/when there are other compatible pets staying with us. "Group Play" option is an additional \$10 per day when requested.

### 5) Intact Pets

a) Intact pets will not be allowed to interact with other animals in any way during their stay (including animals from the same household). If a female is in heat, or comes in to heat during her stay, there will be an additional cleaning fee applied to the total bill.

#### 6) Services & Payment

- a) Reesor Farm Kennels reserves the right to deny service or terminate service due to safety concerns, financial concerns, or inappropriate or uncomfortable situations.
- b) A 25% non-refundable deposit is due prior to confirmation of booking. Deposit may be credited toward the client's account for future use with at least 48 hours notice of cancellation during regular seasons, and 7 days notice during peak seasons (Holidays & school breaks). Any less notice than listed above will result in forfeiture of the full deposit amount.

#### 7) Additional Charges & Fees

- c) Any dog under 1 year of age will incur a "puppy rate" of an additional \$10 per night.
- d) Any dog who is not crate trained/housebroke, or who consistently has accidents in their kennel, multiple times per day is subject to an additional "cleaning fee" at the discretion of Reesor Farm Kennels.
- e) Pick Ups after 12 pm on Weekdays & Saturdays will incur a \$15 day care charge. Pick ups/drop offs on Sunday are between 4-6pm, and a daycare fee is automatically applied to all pick ups. In the case of an emergency, pick up or drop off may be scheduled outside of these times. An after hours fee of \$50 will apply.

By boarding or having your pet groomed with us, you give Reesor Farm Kennels the right to photograph and use pictures of your pet in any and all advertising.
