

Tenant Users Liability Insurance (TULIP)

The Episcopal Diocese of Connecticut

What is a TULIP Program?

- The TULIP Program provides low cost general liability insurance to third party users of various facilities for events at your parish or organization. It protects the third party, the parish or organization and the Episcopal Diocese of Connecticut against claims by guests who may be injured as a result of attending an event. It is an insurance option for prospective users who do not currently have applicable insurance protection that is required by The Episcopal Diocese of Connecticut.

How does the TULIP work?

- When a third party wants to use your facility, you direct the third party to www.onebeaconentertainment.com. They should select "Purchase or Quote" in the "TULIP – Event Insurance" box and provide a seven digit ID code that identifies the parish and facility. You will be provided with the proper ID Codes for your Parish or Organization.
- The third party enters the ID code and answers a few basic questions in a three-step process that provides a quote online.
- The premium quote is based upon the risk associated with the event or activity, the number of days coverage is needed, the number of attendees and if there are any special requirements, such as liquor liability, food service, etc.
- If the third party decides to purchase coverage through this program, they simply enter their credit card information and coverage is bound. A Certificate of Insurance is automatically sent to the third party and Willis.
- That's it! This process avoids the expense of processing and accounting for each transaction.

What Can This Coverage be Used For?

- This program can provide coverage for a wide variety of events, including receptions, birthday parties, Church bazaars, charity functions, instrumental concerts, pageants, recitals, picnics, and small parades. Please contact Willis for a full listing of covered events.

What Activities are Excluded?

- Exclusions include events featuring bounce houses, athletic competitions, carnivals with amusement devices, evangelistic meetings with faith healing or similar activities, fireworks, flea markets, trampolines, water events, and events with a known attendance prior to the event of greater than 5,000 people.
